SUMMARY

Reorganizes mission and governance of State Library. Renames governing body from Trustees of State Library to State Library Board. Modifies composition and number of board members. Changes duties of State Library to promote efficiencies in core library services and to eliminate duplication of effort. Changes State Librarian to gubernatorial appointment. Creates State Reference Coordinating Council to coordinate delivery of library services among state agencies.

- 6 Be It Enacted by the People of the State of Oregon:
- 7 SECTION 1. It is the policy of the State of Oregon to have a State
- 8 Library that:

- 9 (1) Provides library services suitable to support state government
- 10 needs and operations;
- 11 (2) Provides the most efficient delivery model for supplying
- 12 reading-equivalent materials to persons who are blind or print im-
- 13 paired;

- 14 (3) Promotes the establishment, development and support of local
- 15 library services;
- 16 (4) Provides early literacy services and promotes early literacy;
- 17 (5) Eliminates duplication of state agency library services;
 - (6) Leverages federal, state and local funding for the benefit of state

- 2 (7) Promotes the electronic delivery of library and information re-3 sources and services;
- 4 (8) Promotes public, nonprofit and private partnerships; and
- 5 (9) Maintains free access for the public to State Library materials.
- 6 <u>SECTION 2.</u> The State Library shall carry out the functions pre-7 scribed in ORS 357.001 and section 1 of this 2015 Act as follows:
 - (1) The State Library shall support the needs and operations of state government by maintaining and developing appropriate collections of library and information services materials to supplement the collections and services of other libraries in this state and to meet the reference and research needs of state government.
- 13 (2) The State Library shall support delivery of reading-equivalent 14 materials to persons who are blind or print impaired by:
- 15 (a) Acting in cooperation with the Library of Congress in the pro-16 vision of reading-equivalent materials and services in aid of persons 17 who are blind or print impaired; and
- 18 **(b)** Contracting with other entities to provide such materials and 19 services.
 - (3) The State Library shall promote the establishment, development and support of local library services by:
- (a) Expending moneys as may be available to the State Library to demonstrate, develop and support library services in accordance with long-range plans for statewide development and coordination of library services;
- (b) Providing advice and assistance to libraries, library boards, units of local government empowered to establish libraries and departments of state government in matters concerning the establishment, support, operation, improvement and coordination of library services and the cooperation among libraries; and
 - (c) Providing for in-service and continuing education programs for

- 1 library personnel in this state.
- 2 (4) The State Library shall promote early literacy services by dis-3 tributing to local libraries state grant funds appropriated to the State 4 Library for early literacy services and programs.
- 5 (5) The State Library shall prescribe the conditions for the use of 6 state documents in depository libraries and provide for permanent 7 public access to state government publications.
- 8 (6) The State Library shall biennially report to the Legislative As-9 sembly and the Oregon Department of Administrative Services statis-10 tical data on:
- 11 (a) The effectiveness of library services provided to state govern-12 ment;
- 13 (b) The effectiveness of services provided to persons who are blind 14 and persons with visual impairments;
- 15 (c) The degree to which local and school libraries in this state pro-16 vide library services to the people of this state; and
 - (d) The effectiveness of early literacy programs.
- 18 (7) The State Library shall carry out all other activities authorized 19 by law for the development of library services for the people of this 20 state.
- 21 (8) The State Library shall lend State Library books free of charge 22 to the people of Oregon through existing libraries.
- 23 SECTION 3. The State Library may:

- 24 (1) With the advice of the libraries of this state, establish and pro-25 vide a network whereby the library resources in this state are made 26 available to all of the people of this state under reasonable conditions 27 and subject to appropriate compensation to libraries providing library 28 services to persons outside their normal service areas; and
- 29 **(2)** Provide for state participation in regional, national or interna-30 tional library networks and systems designed to increase the quality 31 of library services for the people of this state.

- SECTION 4. (1) The State Library Board is established, consisting of nine voting members.
- 3 (2) The Governor, after consultation with the Oregon Library As-4 sociation, shall appoint seven voting members as follows:
- 5 (a) Two members from two different state agencies;
- 6 (b) One member representing a public library in eastern Oregon;
- 7 (c) One member representing a public library in western Oregon;
- 8 (d) One public member from eastern Oregon;

- 9 (e) One public member from western Oregon; and
- 10 **(f)** One member representing a community college or a public uni-11 versity in this state.
 - (3) The Deputy Superintendent of Public Instruction, or a designee of the deputy superintendent, shall be a voting member of the board.
 - (4) The administrator of the Commission for the Blind, or a designee of the administrator, shall be a voting member of the board.
 - (5) The State Librarian shall serve ex officio as a nonvoting member of the board.
- (6) A board member described in subsection (2) of this section shall 18 serve a four-year term, but a member described in subsection (2) of 19 this section serves at the pleasure of the Governor. Before the expi-20 21 ration of the term of a member, the Governor shall appoint a successor whose term begins on July 1 next following. A member is eligible 22 for reappointment. If there is a vacancy for any cause, the Governor 23 shall make an appointment to become immediately effective for the 24 unexpired term. 25
- 26 (7) A board member described in subsection (2) of this section shall 27 be eligible for reappointment for only one additional term, but any 28 person may be reappointed to the board after an interval of one year.
- 29 (8) The appointment of a board member described in subsection (2) 30 of this section is subject to confirmation by the Senate in the manner 31 prescribed in ORS 171.562 and 171.565.

- 1 (9) A member of the State Library Board is entitled to compen-2 sation and expenses as provided in ORS 292.495.
- SECTION 5. (1) The Trustees of the State Library is abolished on the effective date of this 2015 Act. Any moneys or property held by the Trustees of the State Library on the effective date of this 2015 Act are transferred to the State Library Board. For all purposes, on the effective date of this 2015 Act the State Library Board shall serve as the successor in interest to the Trustees of the State Library.
 - (2) Notwithstanding section 4 of this 2015 Act, the members of the Trustees of the State Library on the day before the effective date of this 2015 Act shall serve as the initial members of the State Library Board who are described in section 4 (2) of this 2015 Act. The Governor shall designate which of the initial members of the board serves for the following specified terms:
- 15 (a) Three shall serve for terms ending June 30, 2016. Upon expira-16 tion of the terms, two shall be replaced by members from two different 17 state agencies and one shall be replaced by a member representing a 18 community college or public university in this state.
 - (b) Two shall serve for terms ending June 30, 2017.
- 20 (c) Two shall serve for terms ending June 30, 2018.

- SECTION 6. (1) The State Library Board shall select one of its members as chairperson and another as vice chairperson, for such terms and with duties and powers necessary for the performance of the functions of such offices as the board determines.
- 25 (2) A majority of the members of the board constitutes a quorum 26 for the transaction of business.
- 27 (3) The board shall meet at least once every three months at a 28 place, day and hour determined by the board. The board may also meet 29 at other times and places specified by the call of the chairperson or 30 of a majority of the members of the board.
- 31 SECTION 7. The State Library Board shall be the policy-making

- 1 body for the State Library. The State Library Board shall:
- 2 (1) Formulate general policies for the State Library and State Li-3 brary operations;
- 4 (2) Adopt rules to carry out the purposes for which the State Li-5 brary is established or for any other purpose authorized by law;
- (3) In consultation with the Oregon Library Association and the Oregon Heritage Commission, adopt long-range plans for the statewide development of each major program identified in section 2 of this 2015 Act and develop key performance metrics for each major program;
- 10 (4) Review and approve budget requests for the State Library that 11 align with the board's long-range plans;
- 12 (5) Develop, adopt and modify a technology plan, including long-13 range expenditures, for statewide database management, digitization 14 of records and integration of services provided by the State Library, 15 the State Archivist, and the online services of the State of Oregon Law 16 Library;
- 17 (6) Conduct certifications of state agency libraries or library ser-18 vices under section 19 of this 2015 Act;
- 19 (7) Review and monitor the State Library and the State Reference 20 Coordinating Council established under section 15 of this 2015 Act;
- 21 (8) Administer the State Library Donation Fund for the benefit of 22 the State Library, except that every gift, devise or bequest for a spe-23 cific purpose shall be administered according to its terms; and
- 24 (9) Report to the Legislative Assembly in January of each odd-25 numbered year on the State Library's efforts to:
- 26 (a) Achieve the statutory mission and programmatic outcomes of 27 the State Library;
- 28 **(b)** Implement initiatives and improvements to interagency coordi-29 nation;
- 30 (c) Implement initiatives and improvements to the electronic de-31 livery of documents and services;

- 1 (d) Implement initiatives and improvements to reference services to state agencies; 2
- (e) Enter into public, nonprofit and private partnerships and report 3 the number of the partnerships entered into by the State Library; and
- (f) Reduce duplication in state agency services and costs related to 5 the mission of the State Library. 6
- **SECTION 8. The State Library Board shall adopt rules:** 7
- (1) Defining reasonable public access to the State Library and its 8 resources and materials. 9
- (2) Defining State Library information science resources, including, 10 but not limited to, print, electronic, subscription and reference ser-11 12 vices.
- (3) Establishing processes and procedures related to state agency 13 use of information science resources of the State Library, as defined in rules adopted under subsection (2) of this section. The rules shall provide that the State Library shall fulfill only state agency requests for resources or services that pertain to the conduct of state business.

(1) The [Trustees of the] State Library **Board** may acquire control and dispose of any and all real and personal property given to or for the benefit of the State Library by private donors, whether the gifts of the property are made to the State Library or to the [trustees thereof] **board** or to the State of Oregon for the benefit of the library.

- (c) Where public library services are not provided as described in paragraph (a) or (b) of this subsection, but by a library of which the governing authority is the primary provider of public library services to a jurisdiction less than county wide, there shall be paid to the library a per capita amount for children residing therein. In addition, a public library having a valid contract with a unit of local government to provide library services to a population beyond its governing authority's jurisdiction shall be paid a per capita amount for the population of children served if specified in the contract. The number of children residing within a jurisdiction that is less than a county shall be estimated using the percentage of children in the total population of the county.
- (d) Where public library services are not provided as described in paragraph (a), (b) or (c) of this subsection, but are provided by a county or district library that has a valid contract with one or more libraries to provide persons in their jurisdiction with library services, there shall be paid to the county or district library a per capita amount for each child residing therein, exclusive of the populations served by libraries eligible for grants under paragraph (c) of this subsection.
- 25 (3) The [Trustees of the] State Library **Board** shall distribute 20 percent 26 of the funds specifically appropriated by the Legislative Assembly for public 27 library services on an area basis.
- 28 (4) The [*Trustees of the*] State Library **Board** may not make a grant that 29 is less than \$1,000 to a qualifying public library for public library services 30 for children.

- 358.575. (1) The voting members of the Oregon Heritage Commission shall be representatives of:
- 3 (a) Heritage interests, including Indian tribes with federal recognition,
