Re: Grandfathering In Current Behavior Analysts in our State

Our state's primary goal for requiring insurance companies to cover ABA services is to **increase access to high quality services by well-trained professionals** for families with autism.

The Behavior Analysis Regulatory Board (BARB) requirements, **currently exclude high quality professionals** providing services already in our communities who have graduate level training and have been using ABA principles for several years, yet do not hold the BCBA required certificate. Not only are these professionals highly qualified, but they also have significant more experience than any newly certified professional holding or pursuing the current BCBA certification.

Without changes to the current statute, our Oregon communities will suffer in these ways:

- 1. Access to the current, experienced, high quality ABA providers <u>will cease</u> for families utilizing their insurance companies for services (with severely challenging behaviors)
- 2. Local businesses providing ABA services <u>will no longer have the income</u> currently made through contracts with state and county services as well as CCOs, and may have to close.
- 3. The demand for services will greatly out number the current number of professionals holding BCBAs.
- 4. Due to the demand, above, the cost for services will be over-inflated, causing ABA services to be unduly expensive for Oregon insurance companies, including the Oregon Health Plan.

Proposed Wording for Certification to be obtained through Grandfathering

The state of Oregon and the Board Analysis Regulating Committee allows select professionals the opportunity to obtain certification by means of a grandfathering option. A grandfathering proviso is a special allowance that permits select applicants to apply before new limits take full effect, while junior start-up applicants must meet new standards. Successful candidates will receive an official accredited certification and all rights to regular certification. This makes certification of experienced practitioners an ideal manner by which professionals can gain recognition for past work and previous qualifications while securing high quality services to families in our Oregon communities.

Proposed Criteria Requirements for Behavior Analysts through Grandfathering Process:

Provide an updated resume which must include a minimum of a master's degree in approved degree categories and 3 years of work directly with clients and families with autism in at least 2 different settings (e.g., schools, clinics, rehabilitation centers, social service agencies, mental health facilities, and/or client homes).

Provide a minimum of 3 letters of endorsement by supervisors and/or clients speaking to your professional role, character, and responsibilities – to include creation, implementation, maintenance, and/or training regarding Functional Behavior Assessments, Behavior Support Plans, designed to improve the quality of life for individuals with a autism.

List of approaches to Applied Behavior Analysis for which the provider is qualified, which may include but are not limited to UCLA / Lovaas, Early Start Denver Model, Pivotal Response Training, Project ImPACT, or other methods.



Synergy Autism Center would not qualify as a provider of ABA services under current criteria
