 - For-profit cemeteries (NOBLE)
 - City/county owned or operated (DUOOS)
 - Special district owned or operated (GYURE)
 - o One representative of crematorium (LOVELAND)
 - o Four public members including one who is a member of a recognized senior citizen organization (CORR, DRESSLEHAUS, GOOLSBY, JUNTUNEN)
 - Senior citizen organization (CORR)
- Member may serve only two consecutive terms
- A board member shall be removed immediately if the member is not a resident of the state, has been absent from three consecutive board meetings, without at least one excused absence, and not licensed and good standing at time of retirement

DUTIES AND AUTHORITY: ORS 692.320 & ORS 692.350

- Adopt rules relating to:
 - o Licensing and issuance of certificates of authority for practitioners
 - o Registration of apprentices
 - Practice and operation of funeral establishments and facilities for final disposition of remains
 - o Sanitary conditions for establishments and facilities where human remains are stored
- Responsible for biennial inspections of facilities and records of funeral establishment, cemeteries, and crematoriums
- The Board may hold hearings, conduct investigations, subpoena witnesses, take testimony to carry out duties
- Publish and distribute changes to statutes and rules
