- Seventeen members appointed by the Governor to three-year terms:

  - Four junior or senior high school teachers (**KUKA, PEREZ, SAGE, SUNDELL**)
  - One elementary school administrator (**COBB**)
  - One junior or senior high school administrator (**ERWIN**)
  - One superintendent of public schools (**SIPE**)
  - One county or education service district superintendent (**SAGER**)
  - One faculty member from teacher education institution (**ANKENY**)
  - One faculty member from state institution of Higher Education (**GIROD**)
  - One member who is a member of a district school board (**CONTRERAS**)
  - Two public members (**BRANTLEY, CHESEBRO**)
- Teachers must have five years' experience and be holders of teaching certificates
- Reappointment for one additional term only

**DUTIES AND AUTHORITY:**        **ORS 342.123- ORS 342.127, ORS 342.140- ORS 342.167, ORS 342.175- ORS 342.180, ORS 342.410, ORS 342.430, ORS 342.465, ORS 342.475- ORS 342.485**

- Elect chair and vice-chair
- Meet at least once every six months
- Appoint executive secretary
- Issue teaching certificates; certify school nurses; revoke and suspend teaching certificates
- Rulemaking
- Establish and collect fees
- Require applicants to have knowledge of civil rights; waive first aid card requirement for disability
- Consult with Board of Nursing (school nurses)
- Consider recommendations of Board of Education, then approve teacher education programs and teacher education programs leading to graduate degrees
