My name is Sydney Scout, I'm 21 years old, currently live in Bend, Oregon, and I'm writing to ask for your support of HB 3250, which would put a cap on carbon emissions by auctioning allowances and distribute the revenue back to Oregonians in the form of a dividend check. Because I was born, raised, and spent the first eighteen years of my life in Anchorage, Alaska, I know that a dividend will really work to help people hold polluters accountable. During these eighteen years, I received the reliable, governmentally distributed, permanent fund dividend check that comes straight from the pockets of oil companies who use our land. Thanks in large part to this check, I can say that I'll be graduating with a bachelors degree from OSU Cascades this June – completely debt free. As a millennial, I can tell you that the coexistence of my current educational and financial situations is rare.

Alaskans love our dividend checks. Because of this extra income, we're not only able to prioritize education, as I have done, but we're also able to put money back into our state's economy, afford increased costs of living that come with life in Alaska, and empower new generations of Alaskans to bear the ever-increasing financial burdens of the post-secondary education system and current job market.

Oil companies have tried to challenge our rights to the Permanent Fund Dividend (PFD), but have been met with nearly unanimous opposition among residents across the state. Whether you're from Anchorage, Seward, Fairbanks, or Juneau, your identity as an Alaskan is inextricably tied to the PFD. We trust our government, because we know they will keep their promises to us and not compromise with oil companies who don't have our best interest in mind.

Because of the positive effect Alaska's dividend has had on my life, I know that HB 3250 will work. In most other conversations about climate action, the people are asked to give something up. It's true that carbon pricing is a necessity if we want our planet to survive. Pricing carbon through a straight cap-and-trade system or carbon tax would necessarily increase gas prices, and would unfairly affect those with lower incomes who spend a higher proportion of their money on energy costs. However, the cap-and-dividend model, by giving \$500 to \$1500 annually to all Oregonians, would effectively negate this.

Adequate action on climate change requires passing long-lasting legislation that can stand up to the powerful forces of the fossil fuel industry. The only example I can think of where the people have been able to stand up, and win, against Big Oil is in my home state. As I come to fall in love with the environment and people of Oregon, I have faith that, with a dividend like Alaska's, we'd be able to give power, and money, to the people of Oregon, too. And when we do we will show the world how people, our natural world, and the economy can win a stable and prosperous future, together.
