Subject: Response to hearing request

During OHA's public hearing overview before your committee you asked for information regarding OHA services. The attached document is submitted to provide the requested information.

1) Demonstrate funding sources for services delivered through OHA's budget and include number of people served and geographic region to the extent possible.

The attached spreadsheet identifies health services provided through OHA, estimates of people served, service funding stream percentages and expenditures from the 2013-15 legislatively approved budget.

Caveats: Please note the number of people served is annual, while the expenditures are biennial. Additionally, the number of people served is not "de-duplicated", meaning for instance that the same individual may have enrolled in the Oregon Health Plan, received a Women, Infant and Children benefit, and residential alcohol and drug treatment services; similarly there may be duplication errors regarding services which crossover and affect more than one person, but are accounted for individually.

The grid does not show geographic region served because most services are provided statewide, but for reference you may find additional information regarding OHA service utilization and caseload by Oregon House District at http://tinyurl.com/nq8jgg2 and we can provide more details regarding utilization in a separate report should you desire.
