in 1968, the Gun Control Act was passed by congress. It is the foundation for a large portion of Federal Law concerning Firearms.

There has been a lot of debate about this "Loophole" regarding firearms. It is widely mentioned as some kind of error, or gross oversight. The claim is absolutely false.

There was nothing missed, or forgotten. It was done with absolute intent, and with good reason by Congress.

The Firearms Owners' Protection Act of 1986, was introduced as Federal firearms law reform. The reforms came after Congressional learned of a substantial pattern of abuse by the ATF directed at Gun Store owners and Gun Owning citizens.

Congress made certain changes or amendments to the GCA were in direct response of Congress to address the abusive behavior of the ATF.

Firearms Owners' Protection Act of 1986 eased some restrictions (purposefully making a loophole that allows private party transfers) with specific intent of limiting the ability of the ATF to further abuse citizens and their rights..

43% of rapes occur between 6:00pm and midnight.*

84% of victims reported the use of physical force only.*

50% of all rape/sexual assault incidents were reported by victims to have occured within 1 mile of their home or at their home.*

In 2001, 11% of rapes involved the use of a weapon — 3% used a gun, 6% used a knife, and 2 % used another form of weapon.*

4 in 10 take place at the victim's home.*

1 in 3 sexual assaults, the perpetrator was intoxicated — 30% with alcohol, 4% with drugs.*

Mr. Prozanski. I have no doubt you love your sister. If you could go back in time, would you give your sister a firearm to help prevent what happened to her? If you were not available?

If this scenario were to happen today...

A caring neighbor could loan/sell her a firearm., so she could be safe. A concerned friend could loan/sell her a firearm., so she could be safe She could get quick access to a firearm by asking acquaintances., so she could be safe.

Under SB-941.,

The neighbor, the concerned friend, the acquaintance, who help their fellow Oregonian would be made into a criminal for having the care, and compassion to see that a victim is not left defenseless.

SB-941 delays the lay abiding public's ability to protect ourselves from the criminals who will not/do not follow laws like this.

Criminals will still be able to get firearms many other cheaper/easier ways.

Any delay imposed upon the public ability to obtain access to a firearm will only benefit the criminal

There are no FFL open to perform a Background Check 9pm – 8am.

A law abiding citizen who suffers a sexual assault at 11pm, they get to come home from the hospital to return to the very place their assault happened. They need protection so they can shut just one of their eyes. Too bad, they will just have to tough it out until the morning.

Don't men deserve ready access to a firearm firearm to protect themselves?






Estimated crime per 100k in District of Columbia








Estimated crime per 100k people in California


















Estimated crime per 100k people in Massachusetts




Estimated crime per 100k people in Massachusetts








Estimated crime per 100k people in United States-Total
