The Multnomah County Courthouse

- Built between 1909 and 1914
- o 7 stories; 256,000 SF
- More than 600,000 visits to the courthouse each year, including residents participating in jury duty
- No decisions have been made for its disposition. The county will work with the community and other stakeholders to determine the building's future.





Seismic Risk to Courthouse

- Courthouse not built to 21st century seismic standards
- Constructed from hollow core bricks
- Courthouse likely to collapse in a major earthquake and could have major damage in a minor earthquake

Financial Impact

- In 2014 the Multnomah County Circuit Court had 189,000 regular case filings plus 242,000 parking violation filings.
- Multnomah County Circuit Court revenue collected contributes in excess of \$66M to the State General Fund every Biennium.

- Construct a new, safe Multnomah County Courthouse
- Build to current seismic standards
- Build to current courthouse best practices for security, technology, and meeting space
- Build to meet the needs of the Judiciary, defendants, litigants, and most importantly the public for the next 100 years
