HB 3045

Removes requirement that school district transfer moneys to other school district for student who attends public charter school in school district and is resident of other school district.

BACKGROUND:

Currently, under ORS 338.155(5), when a student attends a public charter school (the school) located outside that student's resident district, the school district in which the school is located, "shall transfer an amount equal to the per weighted average daily membership (ADMw) of the public charter school that is equal to 50 percent of the amount of the school district's General Purpose Grant per ADMw."

House Bill 3045 removes that requirement. Other similar requirements for public charter schools sponsored by the Department of Education or by an institution of higher education are unaffected.

DE MINIMIS ...

House Bill 3045 removes the requirement that school districts transfer moneys left over after funds have passed through to a charter school.

The amount of moneys is generally *de minimus in value* and the *administrative burden in managing the transfer of moneys is significant.*

Definition of *DE**MINIMIS***:**

"lacking significance or importance : so minor as to merit disregard"

What we Agree with...

Having monies going back to an out of district students resident district, which has no oversight responsibility to the public charter school in another district makes NO sense and needs to end.

School Districts that sponsor Public Charter Schools currently have developed mechanisms to manage such transfer of monies.

Sponsoring school districts have been providing oversight of their public charter schools using the current amount of funding provided by ORS.

Where we disagree...

These dollars are NOT "*de minimus in value"* to those out of district students and the public charter schools functioning on 80% funding.

Public Charter Schools consider every dollar valuable and critical, therefore I would ask that Senate Education Committee amend HB 3045 to send these dollars back to the public charter school –

Not the resident district

Not the sponsoring district

Reasoning...

The resident school district should not have been receiving it to begin with and are not arguing against such change.

The sponsoring district would simply increase their own revenues, without being required by ORS to increase any kinds of service and in fact by their own argument it would reduce the administrative burden in managing the transfer of moneys.

As a public charter school, we are required to report the number of indistrict and out of districts students (and where they are from) each month, therefore we are currently assisting in this administrative burden. So instead, simply return those dollars to the public charter school where those students are attending.

With a \$40,586 we could extend our shuttle buses South into Portland and North into St. Helens, for out of district students!

With \$40,586 a year..... We Could:

On Sauvie Island there is no Fiber for internet. Therefore, we currently have (6) T-1's which gets us 9meg (a step above dial-up) for \$3,600 per month or \$43,200 a year.

With \$40,586 we could afford additional options to increase our bandwidth and SIA students would not have had to start the SMARTER Balance test before Spring Break. We would be able to test more kids at the same time and start much later in the year, but as it is we will test every week until the end of the year.

With \$40,586 a year..... We Could:

Make a difference!

Adding \$40,586 to the SIA \$1,550,187 Budget, which is 2.62% of our budget.

Adding \$40,586 dollars to our Sponsoring Districts Budget of \$20,293,383, which is 0.19% of their budget.

These dollars are real and could make a real impact if they were returned to the Public Charter School. They are significant. These dollars are not **DE MINIMIS** as some proponents of this bill would like you to believe.

What you can do:

Amend the bill so in order to return the out of district dollars to the Public Charter School.
