•We are in support of requiring licensing, inspections, testing, and overall accountability. The most recent tragic in the head shootings of three people who were in charge of a medical marijuana site in Portland Oregon, who had according to law enforcement had 2 prior robberies, should be enough to get your attention.

We must remind our legislators however, that Marijuana is still a federally illegal drug.
