The Youth Development Council's Community Investment Strategy outlines how investments improve the lives of Oregon's youth.

- **Opportunity Youth:** ages 16-20 not in school and not working, and
- **Priority Youth:** ages 6-15 at risk of disconnecting from school and future workforce opportunities

The YDC's Focus

• **Opportunity Youth:** Reconnecting with education, career, and workforce

*Total number, ages 16-24: 68,214, or 15% of youth population, out of 465,000

• **Priority Youth:** Assisting to maintain connection to education and future career opportunities

**Total number: ages 6-15: 201,545, or 54% of population, out of 387,716

*2014 Census Opportunity Index ** ODE Students Eligible for Free and Reduced Lunch, or Economically Disadvantaged youth Oregon Youth Development Council

Who are Opportunity Youth?

- Dropout Youth
- Unemployed Youth
- GEDs
- Pregnant or young parent
- Possibly juvenile justice-involved
- Homeless Youth

Out of School Youth Definition

An out-of-school youth* is an individual who is not attending school.

One or more of the following:

- A school dropout
- Youth within age of compulsory school attendance, but has not attended school for at least the most recent complete school year calendar quarter, based on how local school district defines school year quarters
- Recipient of secondary school diploma or its recognized equivalent
- An individual subject to juvenile or adult justice system
- A homeless individual or a runaway
- An individual who is pregnant or parenting

Breakdown: Chronic Absenteeism

Chronic Absenteeism*

- 30,000 elementary students were chronically absent in 2013-2014 (out of 535,000)
- 18,000 middle school students (12%-16%) were chronically absent
- 33,000 high school students were chronically absent, with 10,000 seniors missing 10% or more of school year.

YDC Community Investment Strategy

Funding for the *Youth & Community* Grant – the most significant and impactful of YDC's grants – comes from YDC's Title XX Social Services Block Grant:

- Sequestered federal funds in FY 2014-2015
- Sequestered again for 2015-2017 biennium
- No state general fund in *Youth & Community* Grant
- Stability of grant in jeopardy due to lack of state general funding

Youth Development Council Vision and Values

<u>Youth-Inclusive</u>: Advocate, question, challenge and be informed by perspectives of youth who are served by our systems.

Equity: Ensure equitable access to programs and services and equitable outcomes across diverse youth populations.

<u>Respect</u>: Recognize and appreciate diversity: cultural/ethnic, socioeconomic geographic, LGBTQ identification, etc., as we support youth programs. Demonstrate respect for tribal sovereignty.

Youth Development Council Vision and Values, continued

Evidence-Based: Support and fund programs and practices that are based upon sound research and proven application.

<u>Performance-based</u>: Support and fund programs with best practices, promising practices and that are practice-based.

<u>Results-Oriented</u>: Define, evaluate and measure programs based upon successful academic and/or workforce outcomes.

Systems thinking: Approach our work with youth programs as part of a continuum of services that stretches from birth to seniors.

Youth Development Council Vision and Values, continued

Innovation: Actively support new and innovative models and approaches to funding and developing programs that support academic improvement for Oregon's youth.

Sustainable Approach: Encourage leveraging and funding support to ensure programs endure beyond initial YDC investments.
