Re: Proposals to increase statewide minimum wage

Dear House Chair Holvey and Senate Chair Dembrow,

The Tualatin Chamber of Commerce represents 409 local businesses with over 15,000 employees and we support Oregon's current minimum wage law that indexes the minimum wage each year based on inflation. Here are some of the reasons why:
