Subject: HB 2997 – Relating to state financial administration Work Session Recommendations

House Bill 2997 appropriates \$250,000 of General Fund to the Oregon Business Development Department (OBDD) to finance cooperative efforts related to harvesting western juniper or manufacturing products from western juniper. OBDD may use these funds to provide technical business assistance, and to support market development and supply chain coordination for western juniper products. Funds may also be used to promote liaison efforts between western juniper harvesters, product manufacturers, and wildlife management programs. The bill identifies the National Policy Consensus Center at Portland State University, and community organizations, as eligible beneficiaries of OBDD support.

The House Committee on Agriculture and Natural Resources reported HB 2997 out with a Do Pass recommendation, and recommended that the bill be referred to the Joint Committee on Ways and Means. A copy of that committee's staff measure summary is attached. The summary notes that western juniper grows across more than six million acres of central and eastern Oregon. The majority of area forested by juniper is split between Bureau of Land Management and privately owned lands. Western juniper in Oregon has increased dramatically since the 1930's due to land management decisions, notably wildfire suppression. Juniper expansion affects plant communities, water availability, fire cycles, forage production and wildlife habitat and biodiversity.

The bill has no revenue impact.

Legislative Fiscal Office Recommendation

The Legislative Fiscal Office recommends amending the bill to change the fund source for OBDD from General Fund to Lottery Funds. Economic development is one of the constitutionally-authorized uses of Lottery Funds, and the Legislature typically allocates Lottery Funds, and not General Fund, to provide support for OBDD's business, innovation and trade programs. The activities funded in this bill qualify for Lottery Funds support. The HB 2997-1 amendments replace the source of funds with Lottery Funds. The amendments do not make any other changes to the bill.

The Legislative Fiscal Office recommends one-biennium budget support of \$250,000 Lottery Funds to OBDD, and that House Bill 2997 be amended by the -1 amendments.

WHAT THE MEASURE DOES:

Appropriates \$250,000 to Oregon Business Development Department to fund efforts by National Policy Consensus Center of Portland State University and community organizations to provide assistance to businesses engaged in western juniper harvesting or manufacturing and promote liaison efforts between public and private activities relating to western juniper and wildlife management. Declares emergency, effective July 1, 2015.

ISSUES DISCUSSED:

PROPOSED AMENDMENTS TO HOUSE BILL 2997

1 Delete lines 4 through 19 of the printed bill and insert:

"SECTION 1. Notwithstanding any other law limiting expenditures, $\mathbf{2}$ the amount of \$250,000 is established for the biennium beginning July 3 1, 2015, as the maximum limit for payment of expenses from lottery 4 moneys allocated from the Administrative Services Economic Devel- $\mathbf{5}$ opment Fund to the Oregon Business Development Department, for 6 business, innovation and trade, for the purpose of funding of cooper-7 ative efforts by the National Policy Consensus Center of Portland 8 State University and community organizations to: 9

"(1) Provide businesses engaged in western juniper harvesting, or
in the manufacturing of products from western juniper, with technical

15 "(2) Promote liaison efforts between public and private activities 16 and programs within this state for western juniper harvesting and re-17 lated manufacturing, and public and private activities and programs 18 for wildlife management in order to address ecological or economic 19 interests and concerns.

20 "<u>SECTION 2.</u> This 2015 Act being necessary for the immediate 21 preservation of the public peace, health and safety, an emergency is 22 declared to exist, and this 2015 Act takes effect July 1, 2015.".
