Oregon Health Authority - Addictions and Mental Health Housing

Sen. Winters: What is the current capacity vs. the actual need for those with mental health issues?

Sen. Bates: What do you think the need is across the state? What is the capacity you currently have? Really measure the need by county and then we can make a plan for funding so that this back door process works. Supply a map.

The attached maps identify the location of the various types of adult mental health residential facilities. There is a map that shows all the types of facilities and there are maps that just show one of the types of facilities. The following table summarizes the capacity of the types of facilities.

Type of Facilities	Number of Facilities	Number of Beds
Adult Foster Homes	125	587
Residential Treatment Homes	58	266
Residential Treatment Facilities	45	475
Secure Residential Treatment Facilities	24	302

This information is used in planning any expansion of capacity.

OHA is addressing the task of identifying the need for residential services with several initiatives. Lynne Saxton is leading the effort to map out the behavioral health services to identify gaps in the system. This mapping will include the identification of residential services. Also, at the direction of the legislature, OHA has revised the methodology to forecast the need of the mandated mental health population. This new methodology will be instrumental in identifying the growth of this population and to quantify the funding needed for services to support these individuals in the community. Most of the individuals in the adult mental health residential system are in the mandated population groups. OHA is also reviewing its methodology of forecasting non-mandated mental health population, with the understanding that it is ideal to provide treatment to people prior to entering the mandated population group. Lastly, OHA is in the process to transition the Medicaid adult mental health residential benefit to the Coordinated Care Organizations (CCO). Effectively managing the residential resources will also increase access to the services by assuring that adults are receiving the right care in the right setting at the right time.

As analysis continues, and as more information becomes available, OHA will make this available to the committee, LFO and DAS CFQ staff.

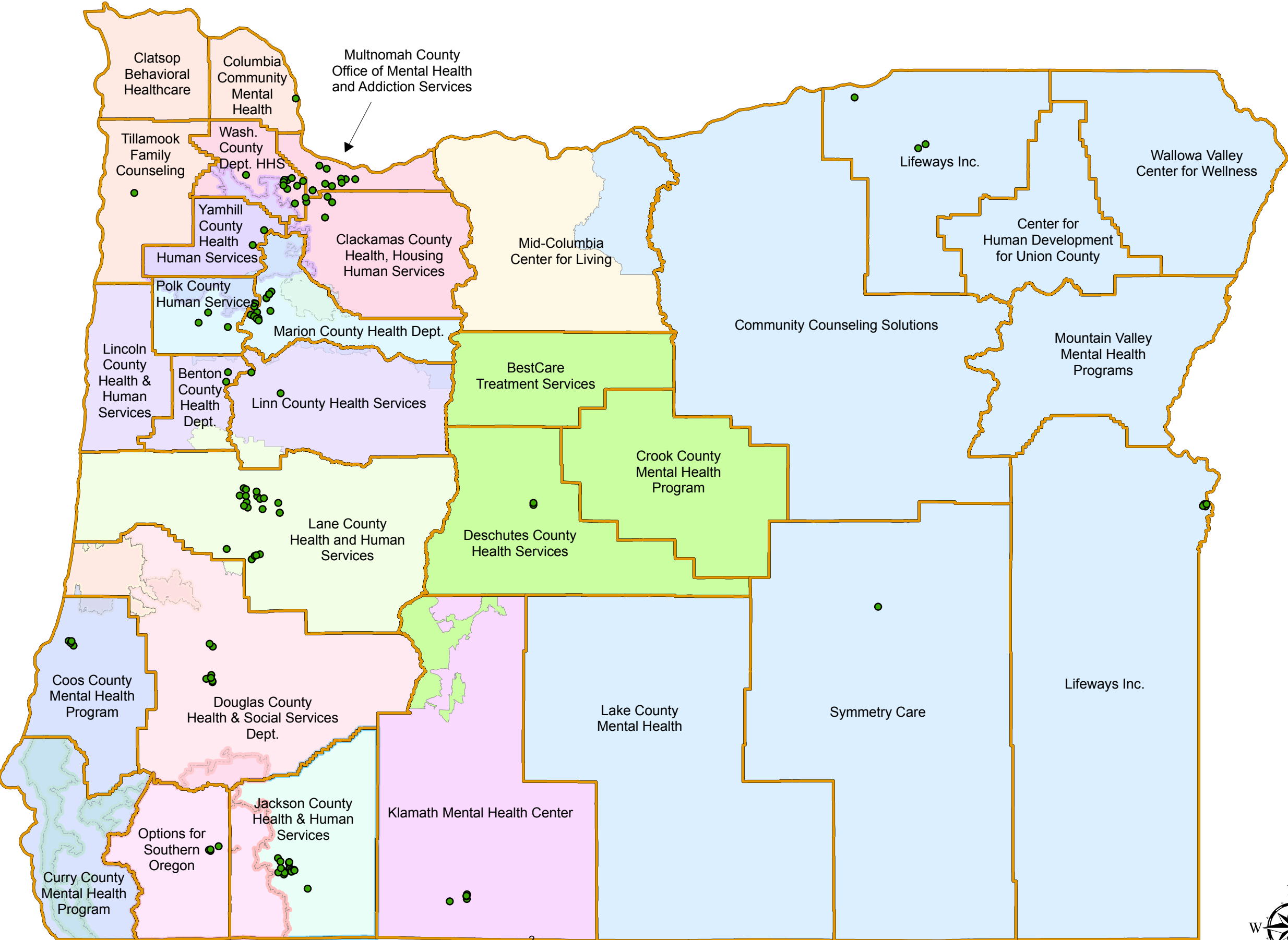
Adult Foster Homes By CMHP Service Area

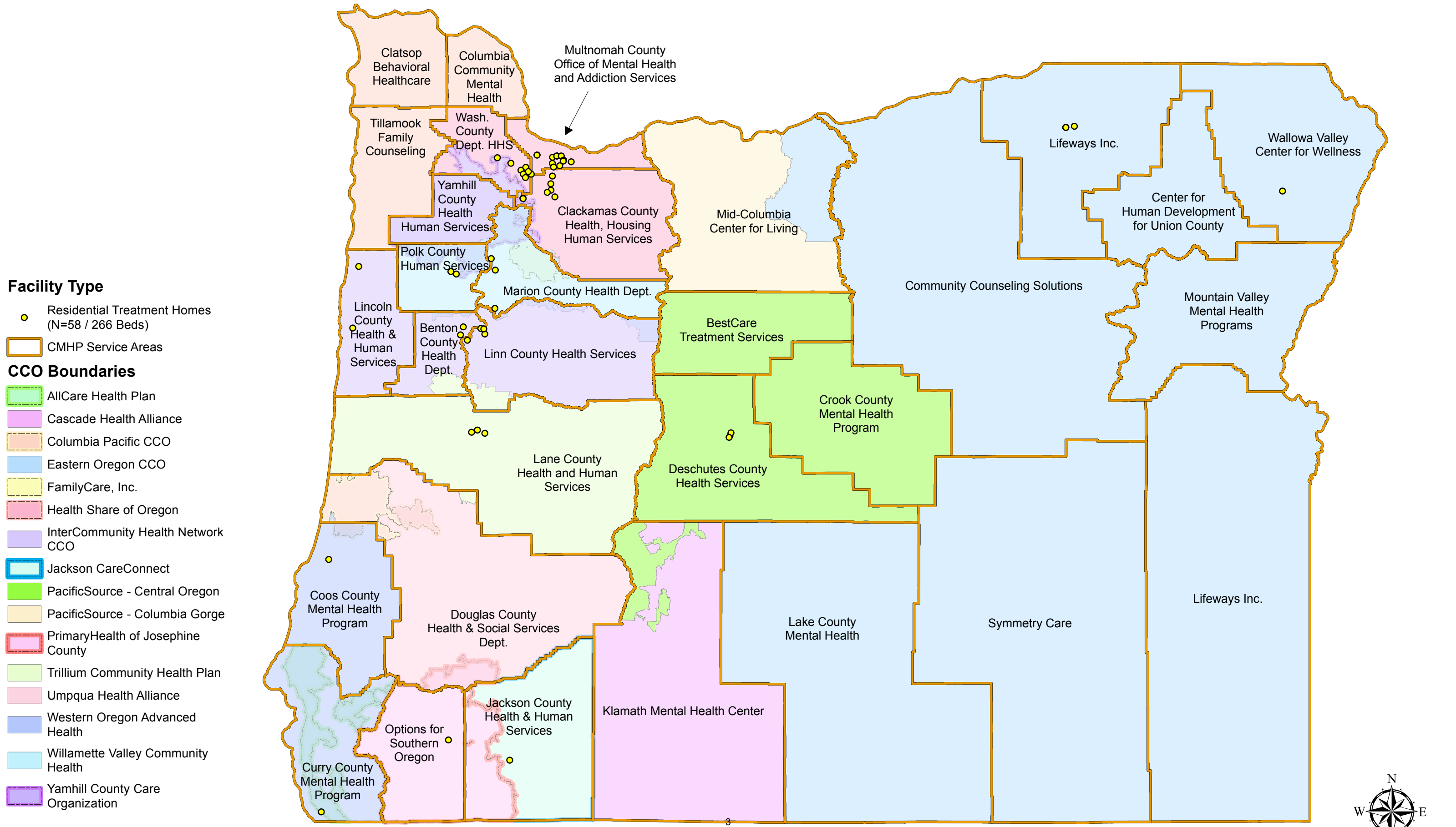

AMH Residential Treatment Facility Type By CMHP Service Area

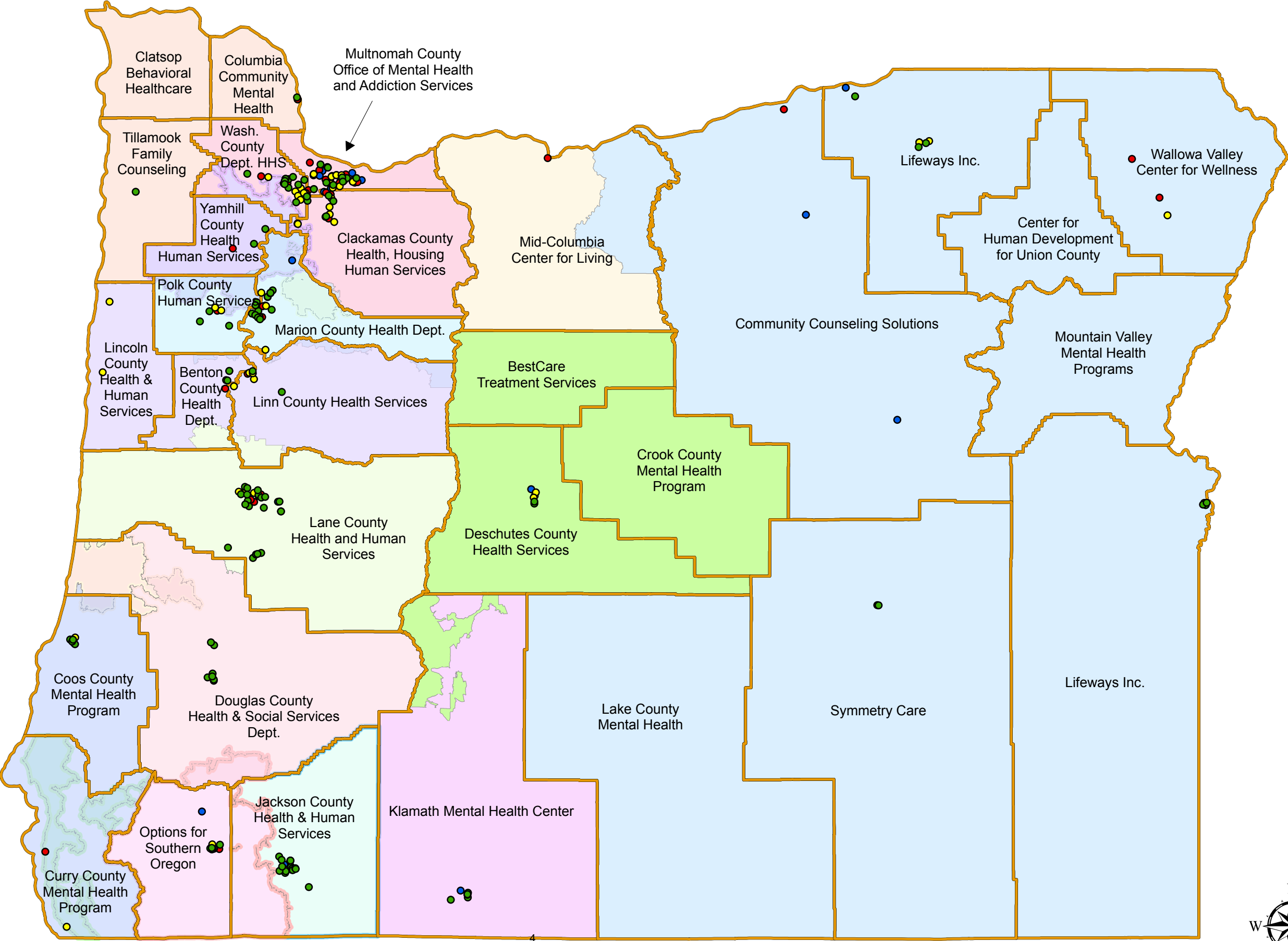

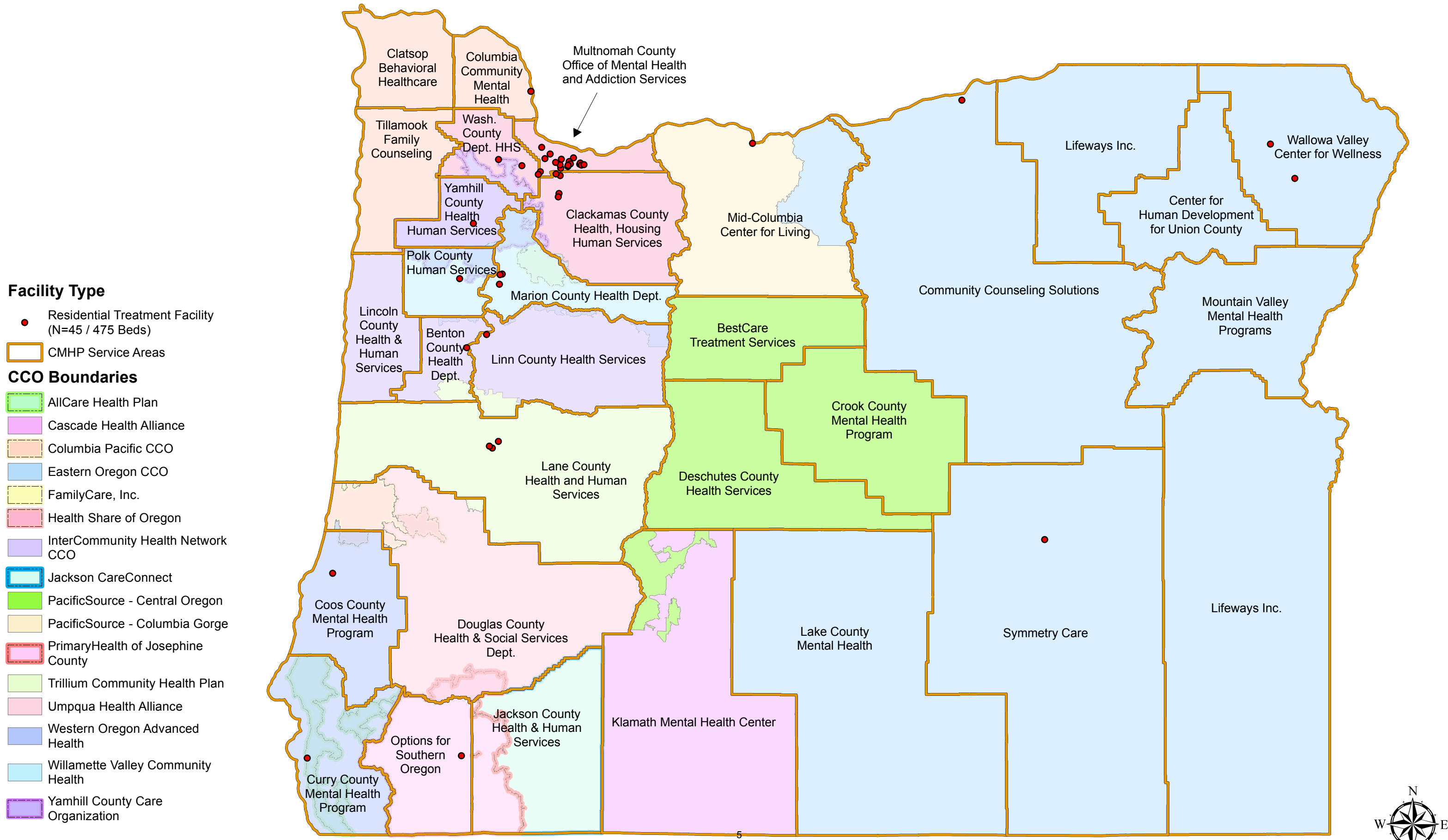

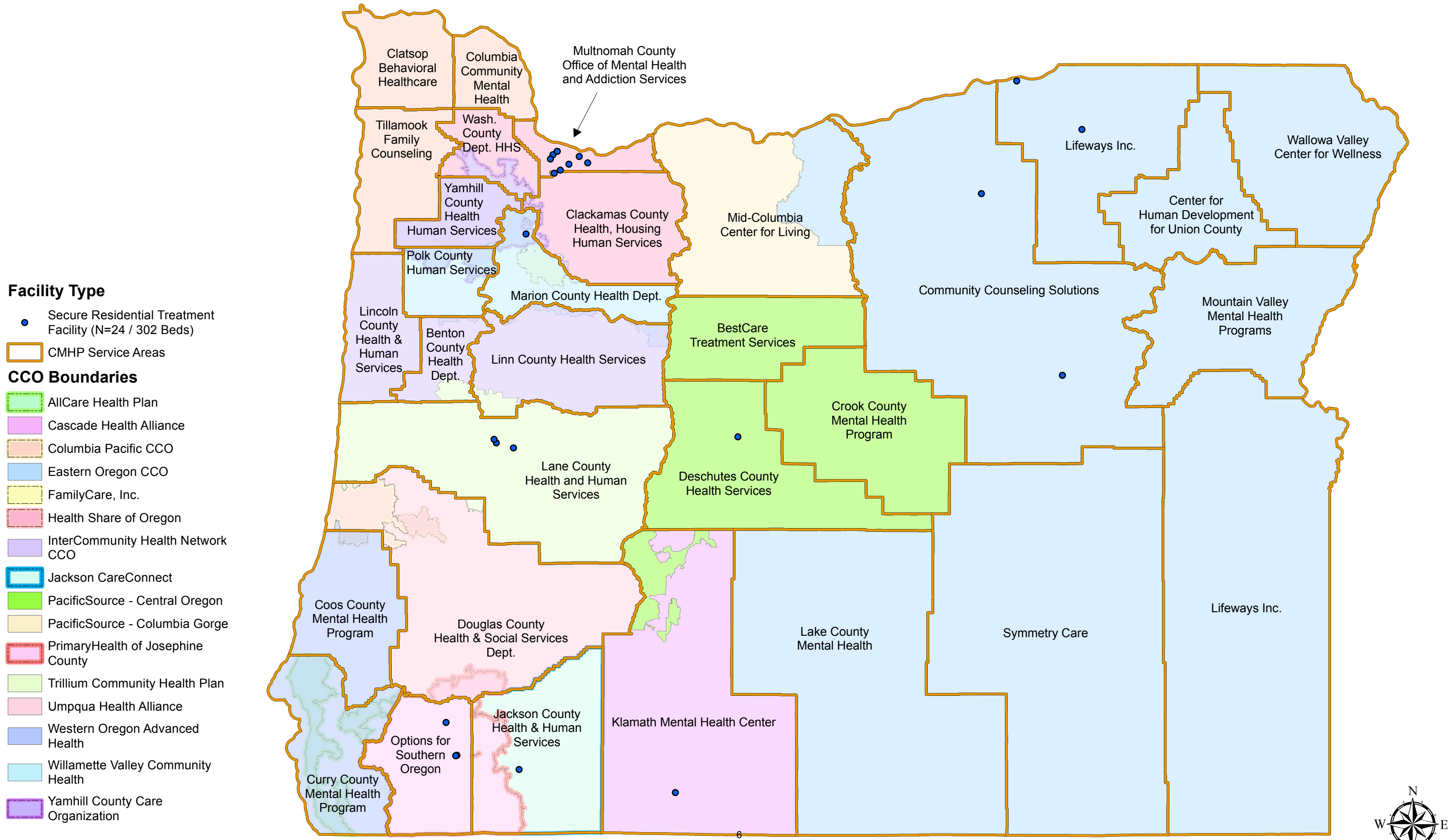


Residential Treatment Facility By CMHP Service Area
