RE: House Bill 3452A

Chair Prozanski and Members of the Committee:

My name is Shelley Day. I am the Director of Community Relations for Camp Attitude Oregon, Inc. I offer this letter in response to House Bill 3452A.

Camp Attitude Oregon, Inc. ("Camp Attitude") is a very unique camp. We believe it is the only camp of its kind in the country. Camp Attitude is a 501(c)(3) non-profit organization, and has been in existence since 1998.

Camp Attitude provides a summer camp experience to special needs families at no cost to the families. Each child (disabled and able-bodied) is paired up with a "buddy" for the week and they spend the week fishing, doing crafts, water fights and spending time at the lake, just to name a few activities. The rule at Camp Attitude is simple: anything an able bodied child gets to do, a disabled child gets to do as well.

Camp Attitude is located just east of Sweet Home along Highway 20. We own approximately 24 acres located along the middle fork of the Santiam River. The physical property has several handicapped accessible cabins and yurts, a pavilion, two "lodges" as well as other structures.

Camp Attitude operates for eight weeks every summer – from approximately the middle of June through the second week of August. We host approximately 25 families each week. Families come from all over the western United States including Utah, Idaho and Arizona in addition to Oregon, Washington and California.

During Camp Attitude's "off season" we rent the facility out to other organizations for retreats and outdoor schools. As you would expect, we have not only the organizations sign liability waivers and indemnification agreements, but we ask that each individual using the facility sign similar agreements.



House Bill 3452A would make those contracts between Camp Attitude and the individuals void.

We understand the purpose of HB 3452A is to prevent property owners from sneaking indemnification clauses into liability waivers signed by the <u>parents</u> of youth who are a member of an organization renting out a facility such as the property owned by Camp Attitude.

House Bill 3452A, in its current form shifts potential liability from the parents of youth to the owner of the property, because the assumption is that the property owner is in a better position to absorb those costs. And normally that would be the case. However, when the property owner is a <u>non-profit organization</u> or and educational organization, the ability to absorb those costs is substantially less.

Further, House Bill 3452A will likely increase the cost of liability insurance for nonprofit organizations as well. Camp Attitude runs on a tight budget, increasing costs make it that much more difficult for Camp Attitude to achieve its purposes: providing a free summer camp experience to special needs families.

We have spoken with the chief sponsor of the measure and he has agreed to an amendment to exclude from the prohibitions of House Bill 3452A properties owned by non-profit organizations or educational organizations. Camp Attitude's legal counsel is working with legislative counsel to have the amendments prepared for your consideration. We appreciate very much Representative Weidner's willingness to amend this bill to avoid unintentional consequences.

Finally, I would like to extend an invitation to everyone on the committee to spend a day at Camp Attitude this summer. Camp Attitude is a remarkable place that touches the lives of hundreds of families each year. Those of us who have special needs children know of Camp Attitude, but my job is to make those of you who do not have a special needs child in your family more aware of our very special camp.

I can say with absolute certainty that a week at Camp Attitude will change your life forever.
