Informational Hearing: SB 215 Workgroup Senate Education Committee, June 9, 2015

Chair Roblan, Vice Chair Knopp, and Committee members:

The Oregon Commissions on Asian and Pacific Islander Affairs (OCAPIA), Black Affairs (OCBA), The Commission for Women (OCFW) and my own Commission have greatly appreciated being invited to be part of the discussion as SB215 workgroup members and to talk with you today about the future of the workgroup as the OEIB comes into closer collaboration with other education coordinating boards and education funding. We encourage this Work Group to further build equity into all of its future considerations, assure the importance of equity in the work of the Chief Education Officer and craft it into goals and statements of purpose, into funding consideration, and tie the structure of education in Oregon to the

outcomes our communities need. We also underscore the importance of our priority of having communities of color, women and Native Americans represented in key positions within education and within its workgroups and associated advisory groups.

We understand that alignment and focus on equity is essential to SB 215 and its potential legacy in Oregon. If equity is not at the core of all we do in education and in this workgroup, and if improvement in outcomes for struggling students is not the measure of our success we have small hope of closing the achievement gap and increasing graduation rates. We support you in your work and offer help in any way.
