


Poverty in Oregon

Measuring Poverty Federal Poverty Level by Family Size, 2012





Poverty rate remains stubbornly high




Profile of Oregon Poverty: Populations and Policies






Poverty rates have exceeded 20% in some rural counties



Poverty rates reach 30-40% for some racial/ethnic minority populations




Job market has collapsed for less-educated workers

Making the Safety Net Work and Making Work Pay

Short-term agenda

- Redesign TANF: Rework income limits and earnings disregards to strengthen work incentives
- Expand access to Employment Related Day Care (ERDC) by increasing access for more children not currently served
- Increase the state Earned Income Tax Credit (EITC) and Working Families Child Care Credit to build transitions from poverty to the middle class
- Extend and expand the Individual Development Account (IDA) Initiative to help low-income families save for housing and education
- Integrate mental health and addiction services into the CCOs

Key Themes

- All people in poverty are not the same and our efforts must target the unique needs of different populations
- Efforts must be better integrated to leverage all available strategies and resources
- Partnerships are critical

Some Next Steps

- Implement recommendations from Design Lab
 - Work with partners to develop and utilize more meaningful measures of economic and social success
 - Discover ways to use the platforms of the sharing economy to provide resources and overcome social isolation of people in poverty
 - Create a "prosperity accounting system" to help people in poverty and case managers monitor and leverage personal and society investments in their well-being.
