

Oregonians urge Lawmakers to Support Senate Bill 324

For Oregon's Economy, Consumer choice, and Public health

In recent months, dozens of Oregonians have written in to papers around the state to express their support for Oregon's Clean Fuels Program. Here is a small sample of their reasons.

"By requiring oil importers to reduce their pollution and open the fuel market beyond gas and diesel, Oregon's Clean Fuels Program will increase access to cleaner-burning fuel sources, help solidify Oregon as a clean fuel leader, and support local and regional jobs. "In other places where a clean fuels program is operating, there's no evidence that it has driven the near-term price of gasoline up. "It is no secret that Oregon needs jobs... Oregon does not have the fossil fuel industries here that are credited with driving other states' recent economic growth, like North Dakota and Texas oil or Wyoming coal.
