## House Bill 2241

Sponsored by Representative DAVIS; Representative CLEM, Senator JOHNSON (Presession filed.)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires Department of Environmental Quality to carry out study and propose recommendations for single, coordinated process for parties to meet certain federal and state requirements for, and to obtain certain releases from liability for, cleanup of hazardous waste. Requires department to report results of study to interim committees of Legislative Assembly on or before September 15, 2016.

A BILL FOR AN ACT

Sunsets January 2, 2017.

Declares emergency, effective on passage.

## Relating to brownfields; and declaring an emergency. Be It Enacted by the People of the State of Oregon: <u>SECTION 1.</u> (1) The Department of Environmental Quality shall study and propose recommendations on legislative, regulatory and other actions necessary to develop a program that would allow parties the opportunity to conduct voluntary removal or remedial actions

## 9 (a) Release from liability under ORS 465.255, 466.640 and 468B.310; and

(b) The ability to satisfy the requirements of, and to obtain certain releases from poten tial liability under, the following federal laws as they may apply to the facility:

- 12 (A) The federal Comprehensive Environmental Response, Compensation and Liability Act,
- 13 as amended, 42 U.S.C. 9601 et seq., P.L. 96-510 and P.L. 99-499;

(B) The federal Resource Conservation and Recovery Act, 42 U.S.C. 6901 to 6992, P.L.
 94-580, as amended; and

16 (C) The federal Toxic Substances Control Act, 15 U.S.C. 2601 to 2671.

(2) In conducting the study required by this section, the department shall consult with
 the United States Environmental Protection Agency.

(3) The department shall make a report of its findings and recommendations under subsection (1) of this section and submit the report to the interim committees of the Legislative
Assembly related to the environment and natural resources in the manner provided under
ORS 192.245 no later than September 15, 2016.

(4) As used in this section, "remedial action" and "removal" have the meaning given
 those terms in ORS 465.200.

25 SECTION 2. Section 1 of this 2015 Act is repealed on January 2, 2017.

26 <u>SECTION 3.</u> This 2015 Act being necessary for the immediate preservation of the public 27 peace, health and safety, an emergency is declared to exist, and this 2015 Act takes effect 28 on its passage.
