(1) As used in this section: 4 $\mathbf{5}$ "(a) 'Consumer' means a natural person who purchases or acquires property, services or credit for personal, family or household purposes. 6 7 "(b) 'Consumer transaction' means a transaction between a consumer and a person that sells, leases or provides property, services or credit to consumers. 8 9 "(c) 'Credit' means a right that a creditor grants to a consumer to defer payment of a 10 debt, to incur a debt and defer payment of the debt, or to purchase or acquire property or 11 services and defer payment for the property or services. 12"(d) 'Creditor' means a person who in the ordinary course of business engages in con-13 sumer transactions. 14 "(e) 'Debt' means an obligation or alleged obligation that arises out of a consumer 15transaction. "(f)(A) 'Debt buyer' means a person that engages in the business of purchasing delin-16 17 quent or charged-off debt for the purpose of collecting the debt, whether the person collects 18 the debt, employs or contracts with another person to collect the debt or retains an attorney 19 to bring an action to collect the debt. 20 "(B) 'Debt buyer' does not include a mortgage banker, as defined in ORS 86A.100, a 21licensee, as defined in ORS 725.010, or a financial institution, as defined in ORS 706.008. "(g) 'Debt collector' means a person that by direct or indirect action, conduct or practice 2223 collects or attempts to collect a debt owed, or alleged to be owed, to a creditor. 24 "(h) 'Debtor' means a consumer who owes or allegedly owes a debt. 25"(i) 'Person' means a natural person, a corporation, a trust, a partnership, an incorporated or unincorporated association and any other legal entity except a body or officer that 2627acts under the statutory authority of this state or the United States. 28"(2)(a) A person may not engage in business as a debt buyer in this state without first 29obtaining a certificate of registration from the Department of Consumer and Business Services. The Director of the Department of Consumer and Business Services by rule may 30 31 specify a form that a debt buyer must use to apply for registration and a fee that the debt 32buyer must pay to obtain the certificate of registration. The amount of the fee apportioned 33 to each applicant for registration may not exceed the applicant's share of the aggregated 34 costs that the department incurs in operating the registry and issuing certificates of regis-35tration. The department shall require an applicant for a certificate of registration under this

1 paragraph to submit:

2 "(A) The applicant's name, address, telephone number and other contact information;

"(B) The name, address, telephone number and other contact information for the applicant's registered agent in this state or a statement that identifies the director as the applicant's registered agent for the purpose of receiving service of process if the applicant does not have a registered agent; and

"(C) The names, addresses, telephone numbers and other contact information for the
applicant's directors, officers, partners or members, if the applicant is a corporation, limited
liability company, partnership, limited partnership or other business entity.

10 (b) Unless the director finds in writing that the applicant has exhibited a repeated pattern of violating this section or ORS 646.639 within the five years before the date of the ap-11 12plication, the director shall issue a certificate of registration. If the director finds a repeated 13pattern of violations, the director may deny a certificate of registration under this subsection. The director may suspend, revoke or impose conditions on a certificate of registra-14 15 tion under this subsection if the director finds that a registrant has exhibited a repeated pattern of violating this section or ORS 646.639 or rules the director adopts under this sec-16 tion or ORS 646.639. 17

18 (c) In addition to requiring a debt buyer to obtain a certificate of registration under 19 paragraph (a) of this subsection, the director by rule may require a debt buyer that operates 20in this state to obtain a certification from a national nonprofit trade association that the 21director identifies as maintaining industry-recognized standards for properly managing pur-22chased debt, if the director by rule also accepts the body of standards that the national 23nonprofit trade association uses to certify debt buyers as standards for governing the operations of debt buyers in this state. In determining whether to accept the nonprofit trade 24 association's body of standards, the director shall evaluate the body of standards that is in 2526effect on the operative date specified in section 8 of this 2015 Act. The director by rule may 27accept changes that occur in the nonprofit trade association's standards after the operative date specified in section 8 of this 2015 Act if the new standards are more stringent in gov-2829 erning the operations of debt buyers in this state than were the previous standards.

40 "(v) The name and address of the original creditor in a form that reasonably enables the 41 debtor to identify the original creditor; and

42 "(vi) That the debt buyer, assignee or debt collector will:

43 "(I) Assume that the debt is valid unless the debtor disputes the validity of all or a por44 tion of the debt or amount of the debt within 30 days after receiving the notice; and

45 "(II) Obtain in writing a verification of the debt or a copy of a judgment against the

debtor and mail the verification or the copy of the judgment to the debtor if the debtor dis-1 2 putes the validity of all or a portion of the debt or amount of the debt within 30 days after receiving the notice. 3 4 "(B) A notice that reads substantially as follows, if a consumer reporting agency may include information about the debt in a consumer report under 15 U.S.C. 1681c, as in effect 5 on the operative date specified in section 8 of this 2015 Act: 6 7 8 The law limits the amount of time during which you can be sued to collect a debt. "(A) Unless or until the debtor disputes the validity of all or a portion of the debt or the 1 2 amount of the debt;

3 "(B) If the debt buyer's, assignee's or debt collector's communication, collection or at-4 tempt to collect the debt does not interfere with the debtor's ability to learn about the debtor's rights under this section or the debtor's right to dispute the validity of all or a 5 portion of the debt or the amount of the debt; and 6

7 "(C) If the debt buyer, assignee or debt collector communicates with the debtor or col-8 lects or attempts to collect the debt without otherwise violating a provision of this section.

"(b) Sell, assign or otherwise transfer a debt to another person if the debtor disputed the 9 validity of all or a portion of the debt or the amount of the debt within 30 days after re-10 ceiving a notice under subsection (3) of this section and if the debt buyer, assignee or debt 11 collector has not mailed to the debtor a written verification of the debt or a copy of a judg-1213ment against the debtor.

"(c) Collect or attempt to collect a debt from an open-end credit account that was 14 15charged off on or after the operative date specified in section 8 of this 2015 Act if the debtor 16 has requested in writing and the debt buyer, assignee or debt collector has not provided:

"(A) A copy of the contract between the debtor and the original creditor or other written 1718 evidence that the debtor owes the debt to the original creditor, including a charge-off state-19 ment or a periodic billing statement that the original creditor sent to the debtor before the 20 debtor's default;

"(B) The total amount of interest the debt accrued after the date of the charge-off;

22"(C) The total amount of any fees, including attorney fees, that the debt accrued after the date of the charge-off; and 23

24 "(D) A statement that lists the complete chain of title for the debt, from the original 25creditor to the present owner, including the names of each owner and the dates during which 26each owner owned the debt.

27"(5) A debtor's failure to dispute the validity of all or a portion of a debt or the amount of a debt under this section is not an admission of the debtor's liability for the debt. 28

29 "(6) To the extent that this section requires or permits a debt buyer to take an action or permits a debtor to communicate with a debt buyer, an assignee of a debt buyer or a debt 30 collector that acts as the debt buyer's agent may take the action or receive the communi-3132cation from the debtor.

33 "(7) Violation of this section by a debt buyer, an assignee of a debt buyer or a debt collector that acts as a debt buyer's agent is an unlawful practice under ORS 646.607 that is 34subject to an investigative demand under ORS 646.618 and enforcement under ORS 646.632 35 and is an unlawful collection practice under ORS 646.639 that is subject to an action under 36 37 ORS 646.641.

debtor's family and with intent to harass or annoy the debtor or any member of the debtor's family.

"(r) Engage in an act or practice prohibited by this subsection when communicating with
a person that the debt collector believes is or might be a debtor.

"(s) Purchase delinquent or charged-off debt for the purpose of collecting the debt without first registering with the Department of Consumer and Business Services under section
1 of this 2015 Act.

"(3) [It shall be an unlawful collection practice for] A debt collector, by use of any direct or indirect action, conduct or practice, [to] may not enforce or attempt to enforce an obligation [made]

"(C) A person that, in attempting to collect or in collecting the person's own claim, uses a fictitious name or any name other than the person's own name that conveys an impression
[indicates] to the debtor that a third person is collecting or attempting to collect the claim;

"(D) A person [in the business of engaging] that engages in the [solicitation of] business of soliciting the right to repossess or in repossessing collateral security due or asserted to be due to another person; or

28 "(E) A person that, in [the collection of] collecting claims from another person:

29 "(i) Uses any name other than the name regularly used in the conduct of the business out of 30 which the claim arose; and

43 "(Q) A public body or an individual [collecting or attempting] that collects or attempts to col-44 lect claims owed, due or asserted to be owed or due to a public body, if the individual is an em-45 ployee of the public body. 1 "(R) A person that receives an assignment of debt in any form without an obligation to pay the 2 assignor any of the proceeds resulting from a collection of all or a portion of the debt.

"(S) A person that engages in the business of purchasing delinquent or charged-off debt
for the purpose of collecting the debt.

5 "[(S)] (**T**) A person for whom the Director of the Department of Consumer and Business Services 6 determines by order or by rule that [*the protection of*] **protecting** the public health, safety and wel-7 fare does not require registration with the Department of Consumer and Business Services as a 8 collection agency.

9 "(2) 'Collection system' means a scheme intended or calculated to be used to collect claims sent,
10 prepared or delivered by:

"(a) A person [who] that in collecting or attempting to collect the person's own claim uses a fictitious name or any name other than the person's own that indicates to the debtor that a third person is collecting or attempting to collect the claim; or

"(b) A person **that is** directly or indirectly engaged in soliciting claims for collection, or collecting or attempting to collect claims owed or due or asserted to be owed or due another person.

"(3) 'Claim' means an obligation [for the payment of] to pay money or [thing of value arising]
 value if the obligation arises out of an agreement or contract, express or implied.

"(4) 'Client' or 'customer' means a person [authorizing or employing] that authorizes or employs a collection agency to collect a claim.

"(5) 'Debtor' means a person [owing] that owes, or is alleged to owe, a claim.

21 "[(6) 'Debts incurred outside this state' means an action or proceeding that:]

22 "[(a) Arises out of a promise, made anywhere to the plaintiff or a third party for the plaintiff's 23 benefit, by the defendant to perform services outside of this state or to pay for services to be performed

24 outside of this state by the plaintiff;]

25 "[(b) Arises out of services actually performed for the plaintiff by the defendant outside of this state 26 or services actually performed for the defendant by the plaintiff outside of this state, if the performance 27 outside of this state was authorized or ratified by the defendant;]

28 "[(c) Arises out of a promise, made anywhere to the plaintiff or a third party for the plaintiff's 29 benefit, by the defendant to deliver or receive outside of this state or to send from outside of this state 30 goods, documents of title or other things of value;]

"[(d) Relates to goods, documents of title or other things of value sent from outside of this state
by the defendant to the plaintiff or a third person on the plaintiff's order or direction;]

33 "[(e) Relates to goods, documents of title or other things of value actually received outside of this 34 state by the plaintiff from the defendant or by the defendant from the plaintiff, without regard to where 35 delivery to carrier occurred; or]

"[(f) Where jurisdiction at the time the debt was incurred was outside of this state.]

37 "[(7)] (6)(a) 'Out-of-state collection agency' means a collection agency located outside of this 38 state [whose] the activities of which, within this state, are limited to collecting [debts incurred 39 outside of this state from debtors] a debt that a debtor located in this state incurs outside this 40 state.

41 "(b) As used in this subsection, 'collecting [debts] a debt' means collecting a debt on behalf 42 of clients located outside this state by means of interstate communications, including telephone, 43 mail or facsimile transmission, from the collection [agency] agency's location in another state [on 44 behalf of clients located outside of this state].

45 "[(8)] (7) 'Person' means an individual, firm, partnership, trust, joint venture, association, limited

1 liability company or corporation.

2 "[(9)] (8) 'Public body' has the meaning given that term in ORS 174.109. [means:]

3 "[(a) The state and any branch, department, agency, board or commission of the state;]

4 "[(b) A city, county, district or other political subdivision or municipal or public corporation or an 5 instrumentality thereof; and]

6 "[(c) An intergovernmental agency, department, council, joint board of control created under ORS 7 190.125 or other like entity that is created under ORS 190.003 to 190.130 and that does not act under 8 the direction and control of any single member government.]

9 "[(10)] (9) ['Registered' or] 'Registrant' means a person that is registered under ORS 697.005 to 10 697.095 or that is registered or licensed as a collection agency under the laws of another state.

11 "[(11)] (10) 'Statement of account' means a report [setting] that sets forth amounts billed, in-12 voices, credits allowed or aged balance due.
