

House Bill 2417

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of Governor John A. Kitzhaber, M.D., for Department of Human Services)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

A BILL FOR AN ACT

2 Relating to temporary assistance for needy families; amending ORS 412.029, 412.049, 412.054 and
3 412.064.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 412.029 is amended to read:

6 412.029. Each money payment of aid made to a representative payee or to a guardian or a
7 conservator under ORS 412.026 or 412.028 shall be expended by the representative payee, guardian
8 or conservator solely to [*purchase*] **make purchases to meet** the needs of the individuals with re-
9 spect to whom the payment is made. However, [*from the money payments*] the individuals may re-
10 ceive from the representative payee, guardian or conservator such [*sums of money*] **portions of the**
11 **money payments** and at such intervals as may be permitted by [*rule or regulation of*] **rules adopted**
12 **by** the Department of Human Services.

13 **SECTION 2.** ORS 412.049 is amended to read:

14 412.049. The Department of Human Services shall:

15 (1) Supervise the administration of the temporary assistance for needy families program under
16 ORS 412.001 to 412.155 [*and 418.647*].

17 (2) Make such rules and regulations and take such action as may be necessary or desirable for
18 carrying out ORS 412.001 to 412.155 [*and 418.647*].

19 (3) Prescribe the form of and print and supply such forms as it deems necessary and advisable.

20 (4) Cooperate with the federal government in matters of mutual concern pertaining to temporary
21 assistance for needy families, including the adoption of such methods of administration as are found
22 by the federal government to be necessary for the efficient operation of the plan for such aid.

23 (5) Accept and disburse any and all federal funds made available to the State of Oregon for
24 temporary assistance for needy families purposes.

25 **SECTION 3.** ORS 412.054 is amended to read:

26 412.054. Application for aid under ORS 412.001 to 412.069 [*and 418.647*] shall be made to the
27 Department of Human Services by the relative with whom the child lives. The application shall be
28 in the manner and upon the form prescribed by the department.

29 **SECTION 4.** ORS 412.064 is amended to read:

30 412.064. The Department of Human Services shall decide whether the child is eligible for aid
31 under ORS 412.001 to 412.069 [*and 418.647*] and determine the date on which the aid granted shall
