In any judicial or administrative proceeding for the establishment or modification of a 6 child support obligation under ORS chapter 107, 108, 109, 110 or 416 or ORS 419B.400, 419B.923, 7 419C.590 or 419C.610, the amount of support determined by the formula established under ORS 8 9 25.275 is presumed to be the correct amount of the obligation. This is a rebuttable presumption and 10 a written finding or a specific finding on the record that the application of the formula would be unjust or inappropriate in a particular case is sufficient to rebut the presumption. The following 11 12criteria shall be considered in making the finding: 13 "(1) Evidence of the other available resources of a parent; 14 "(2) The reasonable necessities of a parent; 15"(3) The net income of a parent remaining after withholdings required by law or as a condition 16 of employment; 17 "(4) A parent's ability to borrow; 18 "(5) The number and needs of other dependents of a parent; 19 "(6) The special hardships of a parent including, but not limited to, any medical circumstances 20 of a parent affecting the parent's ability to pay child support; 21"(7) The needs of the child; "(8) The desirability of the custodial parent remaining in the home as a full-time parent and 2223homemaker; 24 "(9) The tax consequences, if any, to both parents resulting from spousal support awarded and 25determination of which parent will name the child as a dependent; and 26 "(10) The financial advantage afforded a parent's household by the income of a spouse or an-27other person with whom the parent lives in a relationship similar to [husband and wife] that of a 28spouse. "NOTE: Sections 2 and 3 were deleted by amendment. Subsequent sections were not renum-2930 bered. 31 "SECTION 4. ORS 59.350 is amended to read: "59.350. For purposes of ORS 59.005 to 59.451, 59.710 to 59.830, 59.991 and 59.995: 32 33 "(1) A transaction with [a husband and wife] spouses married to each other is treated as a 34 transaction with one person. The securities may be held jointly or individually. 35"(2) A transaction with an entity is treated as a transaction with one person. However, if an

entity is formed substantially for the purpose of acquiring the securities that are offered, each se-1 2 curity holder shall be counted as a separate person.

3 "SECTION 5. ORS 93.180 is amended to read:

4 "93.180. (1) A conveyance or devise of real property, or an interest in real property, that is made to two or more persons: 5

6 "(a) Creates a tenancy in common unless the conveyance or devise clearly and expressly de-7 clares that the grantees or devisees take the real property with right of survivorship.

8 "(b) Creates a tenancy by the entirety if the conveyance or devise is to [a husband and wife] spouses married to each other unless the conveyance or devise clearly and expressly declares 9 10 otherwise.

"(c) Creates a joint tenancy as described in ORS 93.190 if the conveyance or devise is to a 11 12trustee or personal representative.

13"(2) A declaration of a right to survivorship creates a tenancy in common in the life estate with cross-contingent remainders in the fee simple. 14

15 "(3) Except as provided in ORS 93.190, joint tenancy in real property is abolished and the use 16 in a conveyance or devise of the words 'joint tenants' or similar words without any other indication of an intent to create a right of survivorship creates a tenancy in common. 17

"SECTION 6. ORS 105.920 is amended to read:

19 "105.920. There shall be a form of co-ownership of personal property known as joint tenancy. 20 A joint tenancy shall have the incidents of survivorship and severability as at common law. A joint 21tenancy may be created only by a written instrument which expressly declares the interest created 22to be a joint tenancy. It may be created by a transfer or bequest from a sole owner to others, or to 23 the sole owner and others; or from tenants in common or joint tenants to others, or to themselves 24 or some of them, or to themselves or any of them and others; or from [husband and wife] spouses 25married to each other, when holding title as community property or otherwise, to others, or to 26 themselves, or to one of them and to another or others. A transfer or bequest creating a joint 27tenancy shall not derogate from the rights of creditors.

"SECTION 7. ORS 106.020 is amended to read: 28

29 "106.020. The following marriages are prohibited; and, if solemnized within this state, are abso-30 lutely void:

"(1) When either party thereto had a [wife or husband] spouse living at the time of [such] the 3132marriage.

33 "(2) When the parties thereto are first cousins or any nearer of kin to each other, whether of the whole or half blood, whether by blood or adoption, computing by the rules of the civil law, ex-34cept that when the parties are first cousins by adoption only, the marriage is not prohibited or void. 35 36

"SECTION 8. ORS 106.041 is amended to read:

37 "106.041. (1) All persons wishing to enter into a marriage contract shall obtain a marriage li-38 cense from the county clerk upon application, directed to any person or religious organization or congregation authorized by ORS 106.120 to solemnize marriages, and authorizing the person, organ-39 40 ization or congregation to join together as [husband and wife] spouses in a marriage the persons 41 named in the license.

42"(2) The State Registrar of the Center for Health Statistics shall provide a standard form of the 43 application, license and record of marriage to be used in this state that must include:

44 "(a) Each applicant's Social Security number recorded on a confidential portion of the applica-45 tion, license and record of marriage;

1 "(b) Certain statistical data regarding age, place of birth, sex, occupation, residence and previ-2 ous marital status of each applicant;

3 "(c) The name and address of the affiant under ORS 106.050, if required; and

4 "(d) Each applicant's name after marriage as provided in ORS 106.220.

5 "(3) Each applicant for a marriage license shall file with the county clerk from whom the mar-6 riage license is sought a written application for the license on forms prescribed for this purpose by 7 the Center for Health Statistics.

8 "(4) A marriage license must contain the following statement: 'Neither you nor your spouse is 9 the property of the other. The laws of the State of Oregon affirm your right to enter into marriage 10 and at the same time to live within the marriage free from violence and abuse.'

"(5) An applicant may not intentionally make a material false statement in the records requiredby this section.

13 "(6) The county clerk may not issue a marriage license until the provisions of this section and 14 ORS 106.050 and 106.060 are complied with.

"<u>SECTION 9.</u> ORS 106.150 is amended to read:

"106.150. (1) In the solemnization of a marriage no particular form is required except that the parties thereto shall assent or declare in the presence of the clergyperson, county clerk or judicial officer solemnizing the marriage and in the presence of at least two witnesses, that they take each other to be [husband and wife] spouses in a marriage.

"(2) All marriages, to which there are no legal impediments, solemnized before or in any religious organization or congregation according to the established ritual or form commonly practiced therein, are valid. In such case, the person presiding or officiating in the religious organization or congregation shall deliver to the county clerk who issued the marriage license the application, license and record of marriage in accordance with ORS 106.170.

25 "SECTION 10. ORS 106.315 is amended to read:

26 "106.315. (1) A domestic partnership is prohibited and void when:

"(a) Either party to the domestic partnership had a partner[, wife or husband] or spouse living at the time of the domestic partnership unless the partner[, wife or husband] or spouse was the other party to the domestic partnership.

"SECTION 11. ORS 107.005 is amended to read:

"107.005. (1) A marriage may be declared void from the beginning for any of the causes specified
in ORS 106.020; and, whether so declared or not, shall be deemed and held to be void in any action,
suit or proceeding in which [*it*] the marriage may come into question.

42 "(2) When either [*husband or wife*] **spouse** claims or pretends that the marriage is void or 43 voidable under the provisions of ORS 106.020, [*it*] **the marriage** may at the suit of the other be 44 declared valid or that [*it*] **the marriage** was void from the beginning or that [*it*] **the marriage** is 45 void from the time of the judgment. 1 "(3) A marriage once declared valid by the judgment of a court having jurisdiction thereof, in 2 a suit for that purpose, cannot afterward be questioned for the same cause directly or otherwise.

3 "SECTION 12. ORS 107.025 is amended to read:

4 "107.025. (1) A judgment for the dissolution of a marriage or a permanent or unlimited sepa-5 ration may be rendered when irreconcilable differences between the parties have caused the 6 irremediable breakdown of the marriage.

"(2) A judgment for separation may be rendered when:

8 "(a) Irreconcilable differences between the parties have caused a temporary or unlimited 9 breakdown of the marriage;

10 "(b) The parties make and file with the court an agreement suspending for a period not less than 11 one year their obligation to live together as [husband and wife] **spouses**, and the court finds such 12 agreement to be just and equitable; or

"(c) Irreconcilable differences exist between the parties and the continuation of their status as married persons preserves or protects legal, financial, social or religious interest.

15 "SECTION 13. ORS 107.485 is amended to read:

16 "107.485. A marriage may be dissolved by the summary dissolution procedure specified in this 17 section and ORS 107.490 when all of the following conditions exist at the time the proceeding is 18 commenced:

19 "(1) The jurisdictional requirements of ORS 107.025 and 107.075 are met.

20 "(2)(a) There are no minor children born to the parties or adopted by the parties during the 21 marriage;

"(b) There are no children over age 18 attending school, as described in ORS 107.108, either born to the parties or adopted by the parties during the marriage;

24 "(c) There are no minor children born to or adopted by the parties prior to the marriage; and

25 "(d) [*The wife is not*] Neither spouse is now pregnant.

26 "(3) The marriage is not more than 10 years in duration.

27 "(4) Neither party has any interest in real property wherever situated.

"(5) There are no unpaid obligations in excess of \$15,000 incurred by either or both of the parties from the date of the marriage.

30 "(6) The total aggregate fair market value of personal property assets in which either of the 31 parties has any interest, excluding all encumbrances, is less than \$30,000.

32 "(7) The petitioner waives any right to spousal support.

33 "(8) The petitioner waives any rights to pendente lite orders except those pursuant to ORS 34 107.700 to 107.735 or 124.005 to 124.040.

35 "(9) The petitioner knows of no other pending domestic relations suits involving the marriage 36 in this or any other state.

"<u>SECTION 14.</u> ORS 108.010 is amended to read:

38 "108.010. (1) All laws [which] that impose or recognize civil disabilities upon a [wife which] 39 spouse in a marriage that are not imposed upon or recognized as existing [as] with respect to 40 the [husband] other spouse are hereby [are] repealed[; and].

41 "(2) All civil rights belonging to [the husband] a spouse in a marriage not conferred upon the 42 [wife] other spouse prior to June 14, 1941, or [which she] that the other spouse does not have at 43 common law, are hereby [are] conferred upon [her] the other spouse, including, [among other 44 things] but not limited to, the right of action for loss of consortium of [her husband] the spouse.

"108.030. For all civil injuries committed by a [married woman] spouse in a marriage, damages 7 may be recovered from [her alone] that spouse only, and [her husband shall not be] the other 8 spouse is not responsible [therefor] for such civil injuries, except [in case] where [he] the spouses 9 would be jointly responsible with [her] each other if the marriage did not exist. 10

"SECTION 17. ORS 108.040 is amended to read:

"108.040. (1)(a) The expenses of the family and the education of the minor children are charge-1213able upon the property of both [husband and wife] spouses in a marriage who are parents of the minor children, or either of them, and in relation thereto they may be sued jointly or separately. 14

15"(b) As used in this subsection:

"(A) 'Expenses of the family' includes only expenses incurred for the benefit of a member of the 16 family. 17

18 "(B) 'Family' means the [husband, wife] spouses in a marriage and the minor children of the 19 [husband and wife] **spouses**.

"(2) Notwithstanding subsection (1) of this section, after the separation of one spouse from the 20 21other spouse, a spouse is not responsible for debts contracted by the other spouse after the sepa-22ration except for debts incurred for maintenance, support and education of the minor children of the 23spouses.

"(4) An action under this section shall be commenced within the period otherwise provided by 33 34 law.

"SECTION 18. ORS 108.045 is amended to read:

36 "108.045. (1) The expenses of the family and the education of the minor children, including 37 stepchildren, are chargeable upon the property of both [husband and wife] spouses in a marriage 38 who are parents or stepparents of the minor children, or either of them. However, with regard 39 to stepchildren, the obligation shall cease upon entry of a judgment of dissolution.

"SECTION 20. ORS 108.060 is amended to read:

"108.060. When property is owned by either [husband or wife] spouse in a marriage, the other spouse has no interest [therein which] in that property that can be the subject of contract between [them] the spouses, or [such interest as will] that can make the [same] spouses liable for the contracts or liabilities of [either the husband or wife] the other spouse who is not the owner of the property, except as provided in ORS 108.040.

"SECTION 21. ORS 108.080 is amended to read:

"108.080. Should either [*the husband or wife*] **spouse in a marriage** obtain possession or control of property belonging to the other **spouse** either before or after marriage, the owner of the property may maintain an action [*therefor*] **for possession and control of the property**, or for any right growing out of the [*same*] **ownership of the property**, in the same manner and to the same extent as if [*they*] **the spouses** were unmarried.

5 "(4) Copies of bills for testing for parentage and for prenatal and postnatal health care of the 6 mother and child furnished to the adverse party at least 20 days before trial are admissible in evi-7 dence to prove the amount of the charges billed and that the charges were reasonable, necessary 8 and customary.

"136.655. (1) Except as provided in subsection (2) of this section, in all criminal actions in which [the husband] a spouse in a marriage is the party accused, the [wife] other spouse is a competent witness, but neither spouse [and when the wife is the party accused, the husband is a competent witness; but neither husband nor wife in such cases] shall be compelled or allowed to testify [in such cases] in a criminal action, except as provided in ORS 40.255.

20 "(c) For the purposes of industrial injury claims, a condition does not contribute to disability 21 or need for treatment if the condition merely renders the worker more susceptible to the injury.

"(25) 'Self-insured employer' means an employer or group of employers certified under ORS

"(26) 'State Accident Insurance Fund Corporation' and 'corporation' mean the State Accident

43 "(6) If, before the insurer makes payment of loss hereunder, the insured or the legal represen-44 tative of the insured institutes any legal action for bodily injury against any person or organization 45 legally responsible for the use of a vehicle involved in the accident, a copy of the summons and 1 complaint or other process served in connection with the legal action shall be forwarded imme-2 diately to the insurer by the insured or the legal representative of the insured.

3 "(7)(a) The limit of liability stated in the declarations as applicable to 'each person' is the limit 4 of the insurer's liability for all damages because of bodily injury sustained by one person as the 5 result of any one accident and, subject to the above provision respecting each person, the limit of 6 liability stated in the declarations as applicable to 'each accident' is the total limit of the company's 7 liability for all damages because of bodily injury sustained by two or more persons as the result of 8 any one accident.

9 "(b) Any payment made under this coverage to or for an insured shall be applied in reduction 10 of any amount that the insured may be entitled to recover from any person who is an insured under 11 the bodily injury liability coverage of this policy.

"(c) Any amount payable under the terms of this coverage because of bodily injury sustained in an accident by a person who is an insured under this coverage shall be reduced by:

"(A) All sums paid on account of the bodily injury by or on behalf of the owner or operator of the uninsured vehicle and by or on behalf of any other person or organization jointly or severally liable together with the owner or operator for the bodily injury, including all sums paid under the bodily injury liability coverage of the policy; and

18 "(B) The amount paid and the present value of all amounts payable on account of the bodily 19 injury under any workers' compensation law, disability benefits law or any similar law.

"(d) Any amount payable under the terms of this coverage because of bodily injury sustained in an accident by a person who is an insured under this coverage shall be reduced by the credit given to the insurer pursuant to subsection (4)(d)(C) or (D) of this section.

"(e) The amount payable under the terms of this coverage may not be reduced by the amount of liability proceeds offered, described in subsection (4)(d)(B) or (D) of this section, that has not been paid to the injured person. If liability proceeds have been offered and not paid, the amount payable under the terms of the coverage shall include the amount of liability limits offered but not accepted due to the insurer's refusal to consent. The insured shall cooperate so as to permit the insurer to proceed by subrogation or assignment to prosecute the claim against the uninsured motorist.

"(8) No action shall lie against the insurer unless, as a condition precedent thereto, the insured or the legal representative of the insured has fully complied with all the terms of this policy.

"(9)(a) With respect to bodily injury to an insured:

32 "(A) While occupying a vehicle owned by a named insured under this coverage, the insurance 33 under this coverage is primary.

"(B) While occupying a vehicle not owned by a named insured under this coverage, the insurance under this coverage shall apply only as excess insurance over any primary insurance available to the occupant that is similar to this coverage, and this excess insurance shall then apply only in the amount by which the applicable limit of liability of this excess coverage exceeds the sum of the applicable limits of liability of all primary insurance available to the occupant.

<sup>39</sup> "(b) If an insured is an insured under other primary or excess insurance available to the insured <sup>40</sup> that is similar to this coverage, then the insured's damages are deemed not to exceed the higher of <sup>41</sup> the applicable limits of liability of this insurance or the additional primary or excess insurance <sup>42</sup> available to the insured, and the insurer is not liable under this coverage for a greater proportion <sup>43</sup> of the insured's damages than the applicable limit of liability of this coverage bears to the sum of <sup>44</sup> the applicable limits of liability of this insurance and other primary or excess insurance available <sup>45</sup> to the insured. 1 "(c) With respect to bodily injury to an insured while occupying any motor vehicle used as a 2 public or livery conveyance, the insurance under this coverage shall apply only as excess insurance 3 over any other insurance available to the insured that is similar to this coverage, and this insurance 4 shall then apply only in the amount by which the applicable limit of liability of this coverage ex-5 ceeds the sum of the applicable limits of liability of all other insurance.

6 "(10) If any person making claim hereunder and the insurer do not agree that the person is le-7 gally entitled to recover damages from the owner or operator of an uninsured vehicle because of 8 bodily injury to the insured, or do not agree as to the amount of payment that may be owing under 9 this coverage, then, in the event the insured and the insurer elect by mutual agreement at the time 10 of the dispute to settle the matter by arbitration, the arbitration shall take place as described in 11 ORS 742.505. Any judgment upon the award rendered by the arbitrators may be entered in any court 12having jurisdiction thereof, provided, however, that the costs to the insured of the arbitration pro-13ceeding do not exceed \$100 and that all other costs of arbitration are borne by the insurer. 'Costs' 14 as used in this provision does not include attorney fees or expenses incurred in the production of 15evidence or witnesses or the making of transcripts of the arbitration proceedings. The person and 16 the insurer each agree to consider themselves bound and to be bound by any award made by the 17arbitrators pursuant to this coverage in the event of such election. At the election of the insured, 18 the arbitration shall be held:

"(a) In the county and state of residence of the insured;

20 "(b) In the county and state where the insured's cause of action against the uninsured motorist 21 arose; or

22 "(c) At any other place mutually agreed upon by the insured and the insurer.

23 "(11) In the event of payment to any person under this coverage:

24 "(a) The insurer shall be entitled to the extent of the payment to the proceeds of any settlement 25 or judgment that may result from the exercise of any rights of recovery of the person against any 26 uninsured motorist legally responsible for the bodily injury because of which payment is made;

"(b) The person shall hold in trust for the benefit of the insurer all rights of recovery that the person shall have against such other uninsured person or organization because of the damages that are the subject of claim made under this coverage, but only to the extent that the claim is made or paid herein;

"(c) If the insured is injured by the joint or concurrent act or acts of two or more persons, one 3132or more of whom is uninsured, the insured shall have the election to receive from the insurer any 33 payment to which the insured would be entitled under this coverage by reason of the act or acts 34of the uninsured motorist, or the insured may, with the written consent of the insurer, proceed with 35 legal action against any or all persons claimed to be liable to the insured for the injuries. If the 36 insured elects to receive payment from the insurer under this coverage, then the insured shall hold 37 in trust for the benefit of the insurer all rights of recovery the insured shall have against any other 38 person, firm or organization because of the damages that are the subject of claim made under this 39 coverage, but only to the extent of the actual payment made by the insurer;

40 "(d) The person shall do whatever is proper to secure and shall do nothing after loss to preju41 dice such rights;

42 "(e) If requested in writing by the insurer, the person shall take, through any representative not 43 in conflict in interest with the person, designated by the insurer, such action as may be necessary 44 or appropriate to recover payment as damages from such other uninsured person or organization, 45 such action to be taken in the name of the person, but only to the extent of the payment made

hereunder. In the event of a recovery, the insurer shall be reimbursed out of the recovery for ex penses, costs and attorney fees incurred by the insurer in connection therewith; and

3 "(f) The person shall execute and deliver to the insurer any instruments and papers as may be 4 appropriate to secure the rights and obligations of the person and the insurer established by this 5 provision.

6 "(12)(a) The parties to this coverage agree that no cause of action shall accrue to the insured 7 under this coverage unless within two years from the date of the accident:

"(A) Agreement as to the amount due under the policy has been concluded;

"(B) The insured or the insurer has formally instituted arbitration proceedings;

"(C) The insured has filed an action against the insurer; or

"(D) Suit for bodily injury has been filed against the uninsured motorist and, within two years from the date of settlement or final judgment against the uninsured motorist, the insured has formally instituted arbitration proceedings or filed an action against the insurer.

14 "(b) For purposes of this subsection:

"(A) 'Date of settlement' means the date on which a written settlement agreement or release is signed by an insured or, in the absence of these documents, the date on which the insured or the attorney for the insured receives payment of any sum required by the settlement agreement. An advance payment as defined in ORS 31.550 shall not be deemed a payment of a settlement for purposes of the time limitation in this subsection.

"(B) 'Final judgment' means a judgment that has become final by lapse of time for appeal or by entry in an appellate court of an appellate judgment.

"(1) A spouse may effectuate such insurance upon the other spouse.
