HOUSE AMENDMENTS TO A-ENGROSSED HOUSE BILL 2618

1 On page 4 of the printed A-engrossed bill, delete lines 26 through 28 and insert:

2 "(v) Employees of the Department of Human Services who are prohibited from striking under 3 ORS 243.726 and whose duties include the care of residents of residential facilities, as defined in

4 ORS 443.400, that house individuals with intellectual or developmental disabilities.".

5 On page 5, delete lines 40 through 45.

6 On page 6, delete lines 1 through 10 and insert:

⁷ "<u>SECTION 2.</u> (1) The amendments to ORS 238.005 by section 1 of this 2015 Act apply only
⁸ to a person:

9 "(a) Who is employed by the Department of Human Services on the effective date of this 10 2015 Act as a person who is prohibited from striking under ORS 243.726 and whose duties 11 include the care of residents of residential facilities, as defined in ORS 443.400, that house 12 individuals with intellectual or developmental disabilities; or

13 "(b) Who becomes employed by the department after the effective date of this 2015 Act 14 as a person who is prohibited from striking under ORS 243.726 and whose duties include the 15 care of residents of residential facilities, as defined in ORS 443.400, that house individuals 16 with intellectual or developmental disabilities.

17 "(2) A person who is employed by the Department of Human Services under subsection 18 (1)(a) of this section is entitled to service under the Public Employees Retirement System 19 as a police officer only for service performed on or after the effective date of this 2015 Act 20 as an employee of the department who is prohibited from striking under ORS 243.726 and 21 whose duties include the care of residents of residential facilities, as defined in ORS 443.400, 22 that house individuals with intellectual or developmental disabilities.

"<u>SECTION 3.</u> Notwithstanding any other provision of law, the General Fund appropriation
made to the Department of Human Services by section 1 (3), chapter ____, Oregon Laws 2015
(Enrolled House Bill 5026), for the biennium beginning July 1, 2015, for aging and people with
disabilities and intellectual/developmental disabilities programs, is increased by \$528,450, for
the purpose of implementing section 2 of this 2015 Act and the amendments to ORS 238.005
by section 1 of this 2015 Act.

29 "<u>SECTION 4.</u> Notwithstanding any other law limiting expenditures, the limitation on 30 expenditures established by section 3 (3), chapter ___, Oregon Laws 2015 (Enrolled House Bill 31 5026) for the biennium beginning July 1, 2015, as the maximum limit for payment of expenses 32 from federal funds, excluding federal funds described in section 2, chapter ___, Oregon Laws 33 2015 (Enrolled House Bill 5026), collected or received by the Department of Human Services, 34 for aging and people with disabilities and intellectual/developmental disabilities programs, is 35 increased by \$890,218, for the purpose of implementing section 2 of this 2015 Act and the
