SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Establishes Board of Certified Advanced Estheticians within Health Licensing Office. Defines "advanced nonablative esthetics procedure." Requires esthetician to be certified with board to practice advanced nonablative esthetics procedures.

Becomes operative July 1, 2016.

Declares emergency, effective on passage.

4 Be It Enacted by the People of the State of Oregon:

5 SECTION 1. As used in sections 1 to 7 of this 2015 Act:

6 (1) "Advanced nonablative esthetics procedure" means a procedure that uses a laser or

7 other device registered with the United States Food and Drug Administration for nonablative

8 procedures performed on the skin or hair, including, but not limited to, procedures per-

9 formed in conjunction with one of the following modalities:

- 10 (a) Skin rejuvenation;
- 11 (b) Photo rejuvenation;
- 12 (c) Body contouring;
- 13 (d) Dyschromia reduction;
- 14 (e) Cellulite reduction;
- 15 (f) Hair removal or reduction; and
- 16 (g) Nonablative tattoo removal.
- (2) "Certified advanced esthetician" means a person certified to practice advanced
 nonablative esthetics procedures under sections 1 to 7 of this 2015 Act.
- (3) "Esthetician" means a person certified to practice esthetics under ORS 690.005 to
 690.225.
- (4) "Nonablative" means involving an action performed on the skin or hair of a person
 that does not result in the wounding of skin or underlying tissue.
- 23 <u>SECTION 2.</u> (1) A person may not practice advanced nonablative esthetics procedures or 24 use a title, word or abbreviation, including the designation certified advanced esthetician,
- that indicates that the person is authorized to practice advanced nonablative esthetics pro-
- cedures unless the person is certified by the Board of Certified Advanced Estheticians under

section 3 of this 2015 Act. 1 2 (2) Notwithstanding ORS 677.080, a certified advanced esthetician may practice advanced nonablative esthetics procedures. 3 (3) This section does not apply to: 4 (a) A person who is a licensed health care professional if the person's scope of practice 5 includes the practice of advanced nonablative esthetics procedures; or 6 (b) A student enrolled in an advanced nonablative esthetics education program or train-7 ing program or in an advanced nonablative esthetics program that combines education and 8 9 training. SECTION 3. (1) Except as provided in subsection (3) of this section, the Health Licensing 10 Office shall issue a certificate to practice advanced nonablative esthetics procedures to an 11 12 applicant who: 13 (a) Is at least 18 years of age; (b) Is an esthetician in good standing with the Board of Cosmetology; 14 15 (c) Successfully completes: (A) Subject to subsection (2) of this section, an advanced nonablative esthetics education 16 program or training program, or an advanced nonablative esthetics program that combines 17 education and training, that is approved by the Board of Certified Advanced Estheticians; or 18 (B) A nationally recognized program that is approved by the Board of Certified Advanced 19 Estheticians and through which individuals are certified to use lasers or other devices for 20purposes related to practicing advanced nonablative esthetics procedures; 2122(d) Passes an examination adopted by the Board of Certified Advanced Estheticians by rule; and 23(e) Pays the applicable fees established under ORS 676.592. 24 (2) An education program described in subsection (1)(c)(A) of this section must be: 25(a) If the program is located in this state, licensed through the Higher Education Coor-2627dinating Commission; or (b) If the program is not located in this state, substantially equivalent to a program li-28censed through the Higher Education Coordinating Commission. 2930 (3) The office shall issue a certificate to practice advanced nonablative esthetics proce-31 dures to an applicant who: (a) Is an esthetician in good standing with the Board of Cosmetology; 32(b) Is authorized and in good standing to practice advanced nonablative esthetics proce-33 34 dures in a state where the requirements to practice nonablative esthetics procedures are 35substantially similar to the requirements to practice advanced nonablative esthetics procedures in this state; and 36 37 (c) Pays the applicable fee established under ORS 676.592. (4) The office shall issue a temporary certificate to perform advanced nonablative es-38 thetics procedures to an applicant who: 39 (a) Is an esthetician in good standing with the Board of Cosmetology; 40 (b) Meets any qualifications prescribed by the office by rule; and 41 (c) Pays the applicable fee established under ORS 676.592. 42 SECTION 4. (1) A certificate issued under section 3 (1) or (3) of this 2015 Act must be 43 renewed annually. To renew a certificate under this section, a certified advanced esthetician 44

(a) A renewal application; 1 2 (b) Proof that the certified advanced esthetician has completed any continuing education requirements established by the Board of Certified Advanced Estheticians by rule; and 3 (c) The applicable renewal fee established under ORS 676.592. 4 (2) A temporary certificate issued under section 3 (4) of this 2015 Act expires as pre-5 scribed by the office by rule. 6 SECTION 5. (6) A majority of the voting members of the board constitutes a quorum for the trans-28action of business. 2930 (7) Official action by the board requires the approval of a majority of the voting members 31 of the board. (8) The board shall meet at a place, day and hour determined by the board. The board 32also may meet at other times and places specified by the call of the chairperson or of a 33 34 majority of the voting members of the board. SECTION 6. 1 (f) Compile information related to advanced nonablative esthetics procedures and direct 2 the office to disseminate the information to certified advanced estheticians.

(2) In adopting rules under subsection (1)(b) of this section, the board shall adopt rules:

4 (a) Requiring a certified advanced esthetician to conduct all advanced nonablative es-5 thetics procedures in a facility for which a license has been issued under ORS 690.055;

6 (b) Requiring a certified advanced esthetician to maintain client disclosure forms that 7 include, at a minimum, disclosure of the existence of professional liability insurance; and

8 (c) Requiring a certified advanced esthetician to enter into an agreement with:

9 (A) A physician licensed under ORS chapter 677 or a nurse practitioner licensed under

(3) The purpose of an agreement described in subsection (2)(c) of this section is to pro vide a certified advanced esthetician with a licensed health care professional to whom the
 certified advanced esthetician may refer a client of the certified advanced esthetician.

17 <u>SECTION 7.</u> In the manner provided by ORS chapter 183 for contested cases, and after 18 consultation with the Board of Certified Advanced Estheticians, the Health Licensing Office 19 may impose a form of discipline described in ORS 676.612 against any person certified under 20 section 3 of this 2015 Act for a violation of the provisions of sections 1 to 7 of this 2015 Act 21 or of a rule adopted under sections 1 to 7 of this 2015 Act, or for commission of a prohibited 22 act listed in ORS 676.612.

23 <u>SECTION 8.</u> Notwithstanding the requirements listed in section 3 (1)(c) of this 2015 Act, 24 the Health Licensing Office shall, until January 1, 2018, issue a certificate to practice ad-25 vanced nonablative esthetics procedures to an applicant who, in lieu of those requirements:

(1) Provides proof to the office of having been employed for not less than 500 hours as a
 laser operator under the supervision of a health care professional whose scope of practice
 includes the practice of advanced nonablative esthetics procedures; or

(2) Provides proof to the office of having completed 40 hours of education related to laser
 theory and fundamentals and of having completed 24 hours of practical experience perform ing each modality listed in section 1 (1) of this 2015 Act.

32 <u>SECTION 9.</u> (1) Notwithstanding the term of office specified by section 5 of this 2015 Act, 33 of the members first appointed to the Board of Certified Advanced Estheticians:

34 (a) Two shall serve for terms ending December 31, 2016.

35 (b) Two shall serve for terms ending December 31, 2017.

36 (c) Two shall serve for terms ending December 31, 2018.

37 (d) Three shall serve for terms ending December 31, 2019.

(2) Notwithstanding the requirements for board membership specified by section 5 (2)(a)

(2) The Health Licensing Office may take any action before the operative date specified
in subsection (1) of this section that is necessary to enable the office to exercise, on or after

31 <u>SECTION 15.</u> This 2015 Act being necessary for the immediate preservation of the public 32 peace, health and safety, an emergency is declared to exist, and this 2015 Act takes effect 33 on its passage.
