House Bill 2781

Sponsored by Representative PARRISH (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Prohibits Office of Child Care from certifying, registering, recording or providing state funds to child care facility when person with regular presence at facility possesses medical marijuana card. Prohibits child care facility from hiring, employing or otherwise engaging services of person who possesses medical marijuana card as person with regular presence at facility.

Directs Office of Child Care to create system whereby owners and operators of child care facilities may apply to receive information about persons with regular presence at child care facility who possess medical marijuana cards. Authorizes office to charge maximum fee of \$25 for information.

Be It Enacted by the People of the State of Oregon: 4

SECTION 1. Section 2 of this 2015 Act is added to and made a part of ORS 329A.250 to $\mathbf{5}$ 329A.450. 6

SECTION 2. (1) As used in this section: 7

(a) "Child care facility" means: 8

(A) A child care facility that has been certified under ORS 329A.280; 9

(B) A family child care home that has been registered under ORS 329A.330; 10

(C) A preschool recorded program that has become recorded under ORS 329A.255; 11

(D) A school-age recorded program that has become recorded under ORS 329A.257; or 12

(E) Any other child care facility as defined in ORS 329A.250 that receives state funds for 13 14 the operation of the facility.

(b) "Person with a regular presence at a child care facility" means a person who is an 1516 owner, operator, employee, worker or volunteer at a child care facility or another person 17 who will have contact with children at a child care facility.

(c) "Registry identification card" has the meaning given that term in ORS 475.302.

(2)(a) The Office of Child Care may not certify, register, record or provide state funds to 19 20 a child care facility to operate in this state when any person with a regular presence at a child care facility possesses a currently valid registry identification card. 21

22(b) A child care facility may not hire, employ or otherwise engage the services of a per-23son that possesses a currently valid registry identification card if that person would be a person with a regular presence at the child care facility. 24

(3) The Office of Child Care shall verify through the list created and maintained by the 25 26 Oregon Health Authority under ORS 475.331 whether any person with a regular presence at 27a child care facility possesses a currently valid registry identification card before certifying, registering, recording or providing state funds to the child care facility. 28

(4)(a) The Office of Child Care must develop a system whereby the owner or operator of 1 2 a child care facility may verify whether any person with a regular presence at the child care facility possesses a currently valid registry identification card. 3 (b) The owner or operator of a child care facility may obtain the information under this 4 subsection by submitting an application form and a nonrefundable fee as established by the 5 office. The office must determine and apply the fee through rules adopted by the Early 6 Learning Council under ORS 329A.275. Fees obtained under this subsection must be deposited 7 in the Child Care Fund established under ORS 329A.010 (4) to be used for the administration 8 9 of this section. (c) The office shall provide the information requested no later than seven business days 10 after submission of an accurate, complete application under this subsection. 11 12 SECTION 3. ORS 329A.275 is amended to read: 329A.275. (1)(a) The Oregon Health Authority shall create and maintain a list of the persons to 41 whom the authority has issued registry identification cards, the names of any designated primary 42 caregivers, the names of persons responsible for a medical marijuana facility registered under ORS 43 475.314, the addresses of authorized marijuana grow sites and the addresses of registered medical 44

2	(b) The authority shall develop a system by which authorized employees of state and local law
3	enforcement agencies may verify at all times that:
4	(A) A person is a lawful possessor of a registry identification card;
5	(B) A person is the designated primary caregiver of a lawful possessor of a registry identifica-
6	tion card;
7	(C) A location is an authorized marijuana grow site;
8	(D) A location is a registered medical marijuana facility; or
9	(E) A person is the person listed as the person responsible for a registered medical marijuana
10	facility.
11	(2) Names and other identifying information from the list established pursuant to subsection (1)
12	of this section may be released to:
13	(a) Authorized employees of the authority as necessary to perform official duties of the author-

16	thority adequate identification, such as a badge number or similar authentication of authority, only

28	lease or use the information for any purpose other than verification that:
29	(a) A person is a lawful possessor of a registry identification card;
30	(b) A person is the designated primary caregiver of a lawful possessor of a registry identification

32	(c) A location is an authorized marijuana grow site;
33	(d) A location is a registered medical marijuana facility; or
34	(e) A person is the person listed as the person responsible for a registered medical marijuana

36	SECTION 5. Section 2 of this 2015 Act applies to child care facilities that are certified,
37	registered, recorded or provided state funds by the Office of Child Care and to persons with
38	a regular presence at child care facilities who are hired or employed or whose services are
39	otherwise engaged on or after the effective date of this 2015 Act.
