## HOUSE AMENDMENTS TO HOUSE BILL 2845

On page 1 of the printed bill, delete line 3 and insert "646.608.". 1 2 Delete lines 5 through 27 and delete pages 2 through 5 and insert: "SECTION 1. As used in sections 1 to 7 of this 2015 Act: 3 "(1) 'Borrower' means an individual who enters into a finance agreement that is secured 4  $\mathbf{5}$ by a motor vehicle or who, in connection with purchasing or leasing a motor vehicle, incurs an obligation to pay money to a creditor under terms and conditions that are specified in a 6 7 finance agreement. "(2) 'Creditor' means: 8 9 "(a) A person that: 10 "(A) Permits another person to defer or to pay in installments an amount due under a 11 finance agreement that is secured by a motor vehicle; or 12"(B) Otherwise extends credit to another person under a finance agreement that is en-13 tered into in connection with purchasing or leasing a motor vehicle; or 14 "(b) An assignee of a person described in paragraph (a) of this subsection. 15"(3) 'Evaluation period' means a period of at least 30 days after the date on which a 16 borrower purchases a guaranteed asset protection waiver during which, if the borrower did 17 not receive a benefit from the guaranteed asset protection waiver, the borrower may cancel 18 the guaranteed asset protection waiver and receive a full refund of the purchase price. "(4) 'Finance agreement' means a contract or other agreement that is evidence of a 19 20 borrower's obligation to pay money to a creditor and that specifies the terms and conditions 21under which the borrower must repay the obligation. (5) 'Guaranteed asset protection waiver' means a contractual provision of or an adden-22dum to a finance agreement that is secured by a motor vehicle under the terms of which a 2324 creditor agrees to waive the creditor's right to collect all or part of an amount due from a 25borrower under the terms of the finance agreement or to release a borrower from an obli-26 gation to pay the creditor an amount due under a finance agreement if the motor vehicle: 27"(a) Suffers physical damage that is equivalent to a total loss; or 28 "(b) Is stolen and is not recovered. "(6) 'Insurer' means an insurer that is licensed, registered or otherwise authorized to 29transact insurance in this state. 30 31 "(7) 'Motor vehicle' means a self-propelled or towed vehicle that is designed for personal 32or commercial use, such as an automobile, truck, motorcycle, recreational vehicle, allterrain vehicle, snowmobile, camper, boat, personal watercraft or a trailer for a motorcycle, 33 34 boat, camper or personal watercraft. 35"(8) 'Reimbursement insurance policy' means an insurance policy under the terms of

1 which an insurer reimburses a creditor for an amount the creditor must waive under a 2 guaranteed asset protection waiver.

"SECTION 2. (1)(a) A guaranteed asset protection waiver is not insurance and is not 3 4 subject to the provisions of the Insurance Code. A person, other than an insurer, that sells a guaranteed asset protection waiver in compliance with sections 1 to 7 of this 2015 Act does 5 not become subject to the Insurance Code by reason of the sale. 6

(b) Notwithstanding any other provision of law, any cost for a guaranteed asset pro-7 8 tection waiver into which a borrower enters in compliance with the Truth in Lending Act, 15 U.S.C. 1601 et seq., and regulations promulgated under the Truth in Lending Act, must 9 be stated separately in the finance agreement and is not a finance charge or interest. 10

"(2) Sections 1 to 7 of this 2015 Act do not apply to:

"(a) An insurance policy that an insurer offers under the provisions of the Insurance 1213Code;

(b) A debt cancellation contract or debt suspension agreement offered in compliance 14 with 12 C.F.R. 37.2 or 12 C.F.R. part 721, both as in effect on the effective date of this 2015 1516 Act; or

"(c) A state bank, as defined in ORS 706.008 or a credit union, as defined in ORS 723.008. 18 "SECTION 3. A person may not sell a guaranteed asset protection waiver in connection 19 with a sale of a motor vehicle that is used for personal, family or household purposes unless,

at the time of the sale: 20

21(1) The person discloses, in writing and in plain and easily understandable language:

22"(a) The name, address and other contact information for:

23 "(A) The person that sells the guaranteed asset protection waiver;

"(B) The creditor, if different; and 24

25"(C) Any other person that is a party to or has duties, responsibilities or other obli-26gations under the terms of the guaranteed asset protection waiver.

27"(b) The purchase price of the guaranteed asset protection waiver.

"(c) The terms and conditions of the guaranteed asset protection waiver, including but 28 29 not limited to:

"(A) Conditions under which the creditor will waive or decline to waive all or a portion 30 of the obligation that remains under a finance agreement; 31

"(B) The methodology for determining the amount the creditor will waive; and 32

33 "(C) The length of the evaluation period.

"(d) The identity, location and contact information for the person to which the borrower 34must submit a claim for benefits or a refund under the guaranteed asset protection waiver 35 and the procedure the borrower must follow to submit the claim. 36

37 "(e) Conditions under which the borrower may cancel the guaranteed asset protection 38 waiver and the procedure the borrower must follow to cancel, both during the evaluation 39 period and after the evaluation period expires, if the terms of the guaranteed asset pro-40 tection waiver permit cancellation after the evaluation period expires.

41 "(f) The formula or methodology that will apply to calculating the amount of any refund available under the terms and conditions of the guaranteed asset protection waiver if: 42

43 "(A) The borrower cancels the guaranteed asset protection waiver during the evaluation 44 period or, if permitted under the terms and conditions of the guaranteed asset protection 45 waiver, after the evaluation period expires; or

1 "(B) The finance agreement is terminated early.

2 "(2) The guaranteed asset protection waiver provides that the borrower may cancel the 3 guaranteed asset protection waiver during the evaluation period for a full refund of the 4 purchase price if the borrower did not receive any benefits.

5 "(3) The creditor states clearly, and the terms of the guaranteed asset protection waiver 6 provide in writing, that purchasing a guaranteed asset protection waiver is not required in 7 order to obtain credit or complete a purchase or lease of a motor vehicle and does not affect 8 the terms and conditions of credit that a borrower obtains from a creditor.

9 "<u>SECTION 4.</u> (1) A guaranteed asset protection waiver must determine the amount that 10 a creditor waives under the terms of the guaranteed asset protection waiver in accordance 11 with the following methods:

"(a) If primary motor vehicle insurance or third party liability insurance covers the
amount of a total loss of the motor vehicle, the creditor shall waive the difference between:
"(A) The primary insurer's or the third party's determination of the motor vehicle's ac-

15 tual cash value as of the date of the total loss; and

"(B) The amount the borrower owes under the finance agreement.

"(b) If primary motor vehicle insurance or third party liability insurance does not cover a total loss of the motor vehicle, if an insurer that issued the primary motor vehicle insurance or the third party liability insurance is insolvent or if the primary motor vehicle insurance or third party liability insurance have stated values or limits that are less than the actual cash value of the insured motor vehicle, the creditor shall waive the difference between:

23 "(A) The value of the motor vehicle immediately before the loss or theft of the motor 24 vehicle, as shown in a published and generally available regional or national guide to motor 25 vehicle values or from the best available equivalent information, as specified in the guaran-26 teed asset protection waiver; and

27 "(B) The amount the borrower owes under the finance agreement.

28 "(2)(a) A guaranteed asset protection waiver need not require a creditor to waive:

- 29 "(A) A motor vehicle insurance policy deductible;
- 30 "(B) Delinquent, missed or deferred payments;
- 31 "(C) Late fees or charges;
- 32 "(D) Unearned finance charges, interest or lease charges;
- 33 "(E) Unearned rental payments;
- 34 **"(F) Taxes;**
- 35 "(G) Refundable items that include, but are not limited to:
- 36 "(i) Charges associated with service contracts;
- 37 "(ii) Prepaid taxes and fees; or
- 38 "(iii) Credit insurance; or
- 39 "(H) Other similar items that the guaranteed asset protection waiver specifies.

40 "(b) A guaranteed asset protection waiver may specify limits on the amount a creditor

must waive based on a loan to value ratio, a maximum term, a maximum waiver amount or
other limits.

43 "(3) A guaranteed asset protection waiver may require a creditor to waive all or a portion
 44 of a motor vehicle insurance policy deductible.

45 "SECTION 5. (1)(a) A guaranteed asset protection waiver may provide that a borrower

1 may cancel the guaranteed asset protection waiver after the evaluation period expires or 2 that the guaranteed asset protection waiver expires if the finance agreement terminates 3 early. If the guaranteed asset protection waiver permits a borrower to cancel as provided in 4 this subsection and the borrower did not receive a benefit, the borrower is entitled to a re-5 fund of a portion of the purchase price in accordance with a formula or methodology speci-6 fied in the guaranteed asset protection waiver.

7 "(b) A borrower shall apply in writing to the person identified in the guaranteed asset 8 protection waiver for a refund of all or a portion of the purchase price of the guaranteed 9 asset protection waiver within 90 days after the borrower cancels the guaranteed asset pro-10 tection waiver or the finance agreement terminates.

"(2) The terms of the guaranteed asset protection waiver may provide that if the borrower defaults on the obligation set forth in the finance agreement, if the creditor repossesses the motor vehicle that secures the obligation or if the finance agreement terminates for a reason other than the borrower's satisfaction of the obligation set forth in the finance agreement, any refund due as a consequence of the cancellation or termination may be:

16 "(a) Paid directly to the creditor; or

17 "(b) Applied to any outstanding balance on the obligation set forth in the finance agree-18 ment, unless the borrower has paid the obligation in full.

"(3) Unless canceled as provided in this section, a guaranteed asset protection waiver remains in effect as part of the finance agreement for the term set forth in the guaranteed asset protection waiver even if the finance agreement is sold, assigned or otherwise transferred.

23 "<u>SECTION 6.</u> (1)(a) A creditor other than a person that sells a guaranteed asset pro-24 tection waiver in connection with a retail sale of a motor vehicle may insure a guaranteed 25 asset protection waiver with a reimbursement insurance policy.

26 "(b) A person that sells a guaranteed asset protection waiver in connection with a retail 27 sale of a motor vehicle shall insure the guaranteed asset protection waiver with a re-28 imbursement insurance policy that meets the requirements set forth in subsection (2) of this 29 section.

30 "(c) A lessor that leases a motor vehicle does not need to insure a guaranteed asset 31 protection waiver that the lessor sells in connection with the lease.

"(2) A reimbursement insurance policy for a guaranteed asset protection waiver must
 state:

34 "(a) The terms of the obligation the insurer has to reimburse the creditor for amounts 35 the creditor must waive under the terms of the guaranteed asset protection waiver;

36 "(b) That the insurer's obligation to reimburse the creditor extends to the creditor's 37 assignee or any person to which the creditor sells or transfers the finance agreement or the 38 guaranteed asset protection waiver that the reimbursement insurance policy covers;

"(c) That the reimbursement insurance policy remains in effect until canceled in ac cordance with applicable provisions of the Insurance Code; and

41 "(d) That a cancellation of the reimbursement insurance policy does not affect an 42 insurer's obligation under the reimbursement insurance policy for guaranteed asset pro-43 tection waivers that the insured sold, and for which the insurer received premium payments, 44 before the date on which the reimbursement insurance policy was canceled.

45 "(3) A person that sells a guaranteed asset protection waiver in connection with a sale

other details the insurer requires under the terms of the reimbursement insurance policy 3 4 and shall timely forward to the insurer all funds due under the terms of the reimbursement insurance policy. 5 6 "SECTION 7. (1) A person that is subject to sections 1 to 7 of this 2015 Act shall act in 7 a fiduciary capacity with respect to funds the person receives or holds for the benefit of 8 another person. "(2) A person that sells a guaranteed asset protection waiver in connection with a retail 9 sale of a motor vehicle may not: 10 11 "(a) Charge more for the guaranteed asset protection waiver than five percent of the amount the borrower finances under a finance agreement; or 12"(b) Vary the benefits, terms, conditions or price of the guaranteed asset protection 13waiver on account of a borrower's race, sex, sexual orientation, income or education. 14 15"SECTION 8. A violation of a provision of sections 1 through 7 of this 2015 Act is an 16 unlawful practice under ORS 646.608 that is subject to an action under ORS 646.638. "SECTION 9. ORS 646.608, as amended by section 3, chapter 19, Oregon Laws 2014, is amended 1718 to read: 19 "646.608. (1) A person engages in an unlawful practice if in the course of the person's business, 20 vocation or occupation the person does any of the following: 21"(a) Passes off real estate, goods or services as the real estate, goods or services of another. 22"(b) Causes likelihood of confusion or of misunderstanding as to the source, sponsorship, ap-23proval, or certification of real estate, goods or services. (c) Causes likelihood of confusion or of misunderstanding as to affiliation, connection, or asso-24 25ciation with, or certification by, another. 26 "(d) Uses deceptive representations or designations of geographic origin in connection with real 27estate, goods or services. 28 "(e) Represents that real estate, goods or services have sponsorship, approval, characteristics, 29 ingredients, uses, benefits, quantities or qualities that the real estate, goods or services do not have or that a person has a sponsorship, approval, status, qualification, affiliation, or connection that the 30 person does not have. 3132"(f) Represents that real estate or goods are original or new if the real estate or goods are de-33 teriorated, altered, reconditioned, reclaimed, used or secondhand. "(g) Represents that real estate, goods or services are of a particular standard, quality, or grade, 34or that real estate or goods are of a particular style or model, if the real estate, goods or services 35 36 are of another. 37 "(h) Disparages the real estate, goods, services, property or business of a customer or another 38 by false or misleading representations of fact. "(i) Advertises real estate, goods or services with intent not to provide the real estate, goods 39 40 or services as advertised, or with intent not to supply reasonably expectable public demand, unless 41 the advertisement discloses a limitation of quantity. (j) Makes false or misleading representations of fact concerning the reasons for, existence of, 42or amounts of price reductions. 43 44 "(k) Makes false or misleading representations concerning credit availability or the nature of 45 the transaction or obligation incurred. 1 "(L) Makes false or misleading representations relating to commissions or other compensation 2 to be paid in exchange for permitting real estate, goods or services to be used for model or demon-3 stration purposes or in exchange for submitting names of potential customers.

4 "(m) Performs service on or dismantles any goods or real estate if the owner or apparent owner 5 of the goods or real estate does not authorize the service or dismantling.

6 "(n) Solicits potential customers by telephone or door to door as a seller unless the person 7 provides the information required under ORS 646.611.

8 "(o) In a sale, rental or other disposition of real estate, goods or services, gives or offers to give 9 a rebate or discount or otherwise pays or offers to pay value to the customer in consideration of 10 the customer giving to the person the names of prospective purchasers, lessees, or borrowers, or 11 otherwise aiding the person in making a sale, lease, or loan to another person, if earning the rebate, 12 discount or other value is contingent upon an event occurring after the time the customer enters 13 into the transaction.

14 "(p) Makes any false or misleading statement about a prize, contest or promotion used to pub-15 licize a product, business or service.

"(q) Promises to deliver real estate, goods or services within a certain period of time with intent not to deliver the real estate, goods or services as promised.

"(r) Organizes or induces or attempts to induce membership in a pyramid club.

19 "(s) Makes false or misleading representations of fact concerning the offering price of, or the 20 person's cost for real estate, goods or services.

21 "(t) Concurrent with tender or delivery of any real estate, goods or services fails to disclose any 22 known material defect or material nonconformity.

23 "(u) Engages in any other unfair or deceptive conduct in trade or commerce.

24 "(v) Violates any of the provisions relating to auction sales, consignment sales, auctioneers, 25 consignees or auction marts under ORS 698.640, whether in a commercial or noncommercial situ-26 ation.

27 "(w) Manufactures mercury fever thermometers.

"(x) Sells or supplies mercury fever thermometers unless the thermometer is required by federal
 law, or is:

30 "(A) Prescribed by a person licensed under ORS chapter 677; and

31 "(B) Supplied with instructions on the careful handling of the thermometer to avoid breakage 32 and on the proper cleanup of mercury should breakage occur.

"(y) Sells a thermostat that contains mercury unless the thermostat is labeled in a manner to inform the purchaser that mercury is present in the thermostat and that the thermostat may not be disposed of until the mercury is removed, reused, recycled or otherwise managed to ensure that the mercury does not become part of the solid waste stream or wastewater. For purposes of this paragraph, 'thermostat' means a device commonly used to sense and, through electrical communication with heating, cooling or ventilation equipment, control room temperature.

"(z) Sells or offers for sale a motor vehicle manufactured after January 1, 2006, that contains
 mercury light switches.

9 "(2) A representation under subsection (1) of this section or ORS 646.607 may be any manifes-10 tation of any assertion by words or conduct, including, but not limited to, a failure to disclose a fact. 11 "(3) In order to prevail in an action or suit under ORS 646.605 to 646.652, a prosecuting attorney

12 need not prove competition between the parties or actual confusion or misunderstanding.

"(4) An action or suit may not be brought under subsection (1)(u) of this section unless the Attorney General has first established a rule in accordance with the provisions of ORS chapter 183 declaring the conduct to be unfair or deceptive in trade or commerce.

"(5) Notwithstanding any other provision of ORS 646.605 to 646.652, if an action or suit is brought under subsection (1)(xx) of this section by a person other than a prosecuting attorney, relief is limited to an injunction and the prevailing party may be awarded reasonable attorney fees.

19 "<u>SECTION 10.</u> Sections 1 to 8 of this 2015 Act and the amendments to ORS 646.608 by 20 section 9 of this 2015 Act apply to guaranteed asset protection waivers that are sold or of-21 fered for sale on or after the effective date of this 2015 Act.".
