House Bill 3178

Sponsored by Representatives SMITH, BENTZ

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Modifies requirements for pharmacy benefit managers with respect to maximum allowable cost lists.

(1) As used in this section: 19 (a) "List" means [the] a list of the drugs for which a pharmacy benefit manager has established a maximum allowable [costs have been established] cost. 20(b) "Maximum allowable cost" means the maximum amount that a pharmacy benefit manager 2122will reimburse a pharmacy for the cost of a drug. 23(c) "Multiple source drug" means a therapeutically equivalent drug that is available from at 24 least two manufacturers. (d) "Network pharmacy" means a retail [drug outlet registered under ORS 689.305] pharmacy 25that contracts with a pharmacy benefit manager. 2627(e) "Payer" means the entity that pays the claims that are processed by a pharmacy benefit manager for a self-insured plan. 28[(e)] (f) "Therapeutically equivalent" has the meaning given that term in ORS 689.515. 2930 (2) A pharmacy benefit manager: 31 (a) May not place a drug on a list, or must promptly remove a drug from a list, unless there are at least two therapeutically equivalent, multiple source drugs, or at least one generic drug 32[available from only one manufacturer], generally available for purchase by network pharmacies from 33 34 national or regional wholesalers at a significant cost difference. (b) Shall ensure that all drugs on a list are generally available for purchase by pharmacies in 35this state from national or regional wholesalers. 36 37 (c) Shall ensure that [all] no drugs on a list are [not] obsolete. 38 (d) Shall make available to each network pharmacy at the beginning of the term of a contract, and upon renewal of a contract, the method and sources utilized by the pharmacy benefit man-39 ager to determine the maximum allowable cost [pricing of the pharmacy benefit manager]. 40 (e) Shall make [a] each list available to a network pharmacy upon request in a format that is 41 readily accessible to and usable by the network pharmacy. 42 (f) Shall notify each network pharmacy of the procedure for making changes to a list or 43 to the maximum allowable cost for any drug on a list. 44 [(f)] (g) Shall update each list [maintained by the pharmacy benefit manager] every seven [busi-45

ness] calendar days and [make] notify network pharmacies, insurers and payers of any changes 1

2 to the updated lists [, including all changes in the price of drugs, available to network pharmacies in

a readily accessible and usable format]. 3

(h) Shall establish a procedure for removing drugs from a list in a timely manner. 4

[(g)] (i) Shall ensure that dispensing fees are not included in the calculation of maximum al-5 lowable cost. 6

(j) Shall inform an insurer or payer if the pharmacy benefit manager applies a maximum 7 allowable cost to drugs dispensed through a network pharmacy but not through a mail order 8 9 pharmacy.

(k) Shall notify an insurer or payer if the pharmacy benefit manager does not use the 10 same list for billing the insurer or payer as it uses in reimbursing network pharmacies. If 11 12 there is a difference between the list used for billing an insurer or payer and the list used for reimbursing network pharmacies, the pharmacy benefit manager shall inform the insurer 13 or payer of the difference between the maximum allowable cost charged to the insurer or 14 15 payer and the maximum allowable cost paid to a network pharmacy.

16 (3) A pharmacy benefit manager must establish a process by which a network pharmacy may 17 appeal its reimbursement for a drug subject to maximum allowable cost pricing. A network pharmacy may appeal a maximum allowable cost if the reimbursement for the drug is less than the net 18 amount that the network pharmacy paid to the supplier of the drug. An appeal requested under this 19 section must be completed within 30 calendar days of the pharmacy making the claim for which 20appeal has been requested. 21

22(4) A pharmacy benefit manager must provide as part of the appeals process established under 23subsection (3) of this section:

(a) A telephone number at which a network pharmacy may contact the pharmacy benefit man-24 ager and speak with an individual who is responsible for processing appeals; 25

(b) A final response to an appeal of a maximum allowable cost within seven business days; and 27(c) If the appeal is denied, the reason for the denial and the national drug code of a drug that may be purchased by similarly situated pharmacies at a price that is equal to or less than the 2829maximum allowable cost.

30 (5)(a) If an appeal is upheld under this section, the pharmacy benefit manager shall make an 31 adjustment for the pharmacy that requested the appeal from the date of initial adjudication forward. (b) If the request for an adjustment has come from a critical access pharmacy, as defined by the 32Oregon Health Authority by rule for purposes related to the Oregon Prescription Drug Program, the 33 34 adjustment approved under paragraph (a) of this subsection shall apply only to critical access 35pharmacies.

(6) This section does not apply to the state medical assistance program. 36
