House Bill 3267

Sponsored by Representative WILSON

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Establishes Federal Funds Commission. Directs commission to study nature and amount of federal funds that are included in state budget, track availability and expenditure of federal funds in state budget, assess risks and effects of reduction in or loss of federal funds, recommend contingency funding plans for continuing state programs or services affected by reduction in or loss of federal funds and annually report to Legislative Assembly.

| 8 | SECTION 1. (1) There is established a Federal Funds Commission, consisting of five |
| 9 | members appointed by the Governor. |

| 13 | (b) Track the availability and expenditure of federal funds in the budget for state gov- |
| 14 | ernment for each biennium; |
| 15 | (c) Assess the risks of any significant reduction in or loss of federal funds and the effects |
| 16 | any loss could have on particular state or local programs or services; |
| 17 | (d) Recommend contingency funding plans for continuing state programs or services that |
| 18 | would be affected by a reduction in or loss of federal funds; and |
| 19 | (e) Report to the Legislative Assembly not later than October 1 of each calendar year |
| 20 | and to any committee or interim committee of the Legislative Assembly upon request of the |
| 21 | chairperson of the committee. |
| 22 | (3) The term of office of each member is four years, but a member serves at the pleasure |
| 23 | of the Governor. Before the expiration of the term of a member, the Governor shall appoint |
| 24 | a successor whose term begins on January 1 next following. A member is eligible for reap- |
| 25 | pointment. If there is a vacancy for any cause, the Governor shall make an appointment to |
| 26 | become immediately effective for the unexpired term. |

| 28 | manner prescribed in ORS 171.562 and 171.565. |
