The plan shall include: 6 "(a) Educational materials that are appropriate and effective for a broad audience, including, 7 but not limited to, pesticide applicators, consultants, dealers, operators and trainees and private applicators, as those terms are defined in ORS 634.006, and members of the public; and 8 9 (b) A communication strategy for dissemination of educational materials using media sources, 10 state agencies, associations and organizations.". 11 On page 2, line 4, delete "locations of such". 12In line 5, delete "colonies and the name,". 13 In line 26, delete "honeybee and native" and insert "pollinator research that is predominantly 14 focused on honeybees.". 15Deletes lines 27 through 45. 16 On page 3, delete lines 1 through 27 and insert: 17 "NOTE: Section 4 was deleted by amendment. Subsequent sections were not renumbered.". 18 Delete lines 42 through 44 and insert: 19 "(4) The department shall apply \$10 of each registration fee collected pursuant to ORS 634.016 20 to fulfill the provisions of section 1 (2), chapter 40, Oregon Laws 2014. 21"SECTION 6. ORS 634.326, as amended by section 5 of this 2015 Act, is amended to read: 22"634.326. (1) The State Department of Agriculture shall deposit all fees paid to it under the provisions of this chapter in the Department of Agriculture Service Fund. Such moneys are contin-2324 uously appropriated to the department for the purpose of administering and enforcing the provisions 25of this chapter. 26 "(2) An amount of the fees and moneys referred to in subsection (1) of this section not to exceed 2710 percent of registration fees received under ORS 634.016 may be used by the department pursuant 28to agreements entered into between the department and the Dean of the College of Agricultural 29Sciences of Oregon State University, with the advice of the Minor Crops Advisory Committee for the purposes set forth in subsection (3) of this section. 30 31 "(3) The amounts provided for in subsection (2) of this section shall be used by the Dean of the 32College of Agricultural Sciences of Oregon State University for research projects and investigations 33 agreed upon by the dean and the department directed toward obtaining pesticide use registrations

needed by growers to produce crops economically in Oregon.
"(4) The department shall apply \$10 of each registration fee collected pursuant to ORS 634.016
