Section 2 of this 2015 Act is added to and made a part of ORS chapter 414. 3 "SECTION 2. (1) The Oregon Health Authority shall prescribe by rule appropriate time 4 frames within which a pregnant medical assistance recipient who needs general or specialty $\mathbf{5}$ dental care must have the opportunity to be seen, or referred for, and provided: 6 7 "(a) Emergency dental services; "(b) Urgent dental services; and 8 9 "(c) Routine dental services. 10 "(2) The time frames prescribed by the authority for recipients whose medical assistance 11 is reimbursed on a fee-for-service basis shall be consistent with the time frames for recipi-12ents enrolled in coordinated care organizations and dental care organizations. 13 "(3) The authority shall adopt a procedure to ensure that a pregnant medical assistance 14 recipient who is not enrolled in a coordinated care organization or a dental care organization 15has the opportunity to receive a dental screening within 30 days after the recipient reports 16 to the authority that she is pregnant. 17 "SECTION 3. (1) The Oregon Health Authority shall adopt procedures to ensure that the 18 authority collects and processes the information necessary to determine if the requirements of section 2 of this 2015 Act are met. 19 20 "(2) No later than December 1, 2016, the authority shall report to the Legislative As-21sembly, in the manner provided by ORS 192.245, on: "(a) Whether the wait times for pregnant women to be seen, or referred for, and provided 22dental care are in accordance with the rules prescribed by the authority under section 2 of 2324 this 2015 Act; and 25"(b) The effectiveness of the procedure adopted by the authority under section 2 of this 262015 Act to ensure that a pregnant medical assistance recipient who is not enrolled in a co-27ordinated care organization or a dental care organization has the opportunity to receive a 28dental screening within 30 days after the recipient reports to the authority that she is pregnant. 29"SECTION 4. (1) Section 2 of this 2015 Act becomes operative on January 1, 2016. 30 31 "(2) The Oregon Health Authority shall take any action before the operative date speci-32fied in subsection (1) of this section that is necessary for the authority to implement the requirements of section 2 of this 2015 Act on and after the operative date specified in sub-33 34 section (1) of this section.". 35In line 8, delete "2" and insert "5" and delete "1" and insert "3" and delete "December 31,

- 2 In line 9, delete "3" and insert "6".
