## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Modifies requirements for health benefit plan coverage of telemedical health services. Declares emergency, effective on passage.

## 1 A BILL FOR AN ACT

2 Relating to payment for health services; creating new provisions; amending ORS 743A.058; and de-

3 claring an emergency.

4 Be It Enacted by the People of the State of Oregon:

5 **SECTION 1.** ORS 743A.058 is amended to read:

6 743A.058. (1) As used in this section:

7 (a) "Health benefit plan" **includes**:

8 (A) A health benefit plan as defined [has the meaning given that term] in ORS 743.730[.]; and

9 (B) A self-insured health plan offered through the Public Employees' Benefit Board or

10 the Oregon Educators Benefit Board.

(b) "Health professional" means a person licensed, certified or registered in this state to
provide health care services or supplies.

[(b)] (c) "Originating site" means the physical location of the patient [receiving a telemedical
health service].

[(c) "Telemedical" means delivered through a two-way video communication that allows a health
professional to interact with a patient who is at an originating site.]

(2) A health benefit plan must provide coverage of a [telemedical] health service that is pro vided using synchronous two-way interactive video conferencing if:

(a) The plan provides coverage of the health service when provided in person by [the] a health
professional;

21 (b) The health service is medically necessary; [and]

22 (c) The health service [does not duplicate or supplant a health service that is available to the pa-

23 tient in person.] is determined to be safely and effectively provided using synchronous two-way

interactive video conferencing according to generally accepted health care practices and
standards; and

(d) The application and technology used to provide the health service meet all standards
required by state and federal laws governing the privacy and security of protected health
information.

29 [(3) An originating site for a telemedical health service subject to subsection (2) of this section in-30 cludes but is not limited to a:]

The amendments to ORS 743A.058 by section 1 of this 2015 Act apply to a health benefit plan issued or renewed on or after the effective date of this 2015 Act. 24 25SECTION 3. This 2015 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2015 Act takes effect 2627on its passage.
