## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Makes law requiring certain health care workers to submit demographic, education and other information to health care worker regulatory boards apply to all health care workers. Changes law so that submission of information is required only when renewing license to practice profession.

Becomes operative January 1, 2016.

Declares emergency, effective on passage.

15 (7) Using information collected under subsection (2) of this section, the authority shall create and maintain a health care workforce database that will provide data, including data 16 related to the diversity of this state's health care workforce, upon request to state agencies 17 18 and to the Legislative Assembly. The authority may contract with a private or public entity to establish and maintain the database and to perform data analysis. 19

SECTION 3. (1) For individuals applying to renew a license to practice a regulated pro-2122fession with the Oregon Board of Dentistry, Board of Licensed Dietitians, Oregon State 23Board of Nursing, State Board of Pharmacy, Oregon Medical Board, Occupational Therapy Licensing Board and Physical Therapist Licensing Board, the amendments to ORS 676.410 by 24 section 1 of this 2015 Act apply to applications to renew a license to practice a regulated 25profession that are submitted on or after the operative date specified in section 4 of this 2015 2627Act.

(2) For individuals applying to renew a license to practice a regulated profession with the 28State Board of Examiners for Speech-Language Pathology and Audiology, State Board of 2930 Chiropractic Examiners, State Board of Licensed Social Workers, Oregon Board of Licensed 31 Professional Counselors and Therapists, State Board of Massage Therapists, Oregon Board of Naturopathic Medicine, Respiratory Therapist and Polysomnographic Technologist Li-32censing Board, Oregon Board of Optometry, State Board of Psychologist Examiners and 33 34 Board of Medical Imaging, the amendments to ORS 676.410 by section 1 of this 2015 Act apply 35to applications to renew a license to practice a regulated profession that are submitted on or after the date on which rules are adopted for health care workers regulated by a health 36 37 care workforce regulatory board pursuant to ORS 676.410 (3).

38 SECTION 4. (1) The amendments to ORS 676.410 by section 1 of this 2015 Act and the repeal of ORS 442.468 by section 2 of this 2015 Act become operative on January 1, 2016. 39

40 (2) The Oregon Health Authority may take any action before the operative date specified in subsection (1) of this section that is necessary to enable the authority to exercise, on and 41 after the operative date specified in subsection (1) of this section, all the duties, powers and 42 functions conferred on the authority by the amendments to ORS 676.410 by section 1 of this 43 2015 Act. 44
