# Senate Bill 235

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with presession filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Governor John A. Kitzhaber, M.D., for Oregon Military Department)

#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Changes name of Oregon Pre-Disaster Mitigation Fund to Oregon Emergency Preparedness Account. Changes name of Oregon Disaster Response Fund to Oregon Disaster Response Account. Changes name of Oregon Local Disaster Assistance Loan and Grant Account to Oregon Local Disaster Assistance Loan and Grant Subaccount.

Changes each renamed fund from fund established separate and distinct from General Fund to account established within General Fund.

Declares emergency, effective on passage.

### 4 Be It Enacted by the People of the State of Oregon:

**SECTION 1.** ORS 401.532 is amended to read:

6 401.532. (1) The [Oregon Pre-Disaster Mitigation Fund] Oregon Emergency Preparedness Ac-

7 count is established [in the State Treasury, separate and distinct from] within the General Fund.

8 Moneys received from federal grants for [pre-disaster mitigation] emergency preparedness efforts

9 shall be deposited into the [Oregon Pre-Disaster Mitigation Fund] Oregon Emergency

10 **Preparedness Account**. Moneys in the [*fund*] **account** are continuously appropriated to the Oregon

11 Military Department to be used to:

(a) Help state agencies and local government units with Federal Emergency Management
Agency approved mitigation plans in this state prior to the occurrence of natural disasters; and

(b) Ensure, to the extent possible, that state and local agencies and officials are prepared to respond to threats of human-caused disaster, including but not limited to acts of terrorism.

16 (2) The [Oregon Pre-Disaster Mitigation Fund may receive] department may deposit in the 17 account gifts, grants, bequests, endowments and donations from public and private sources for 18 purposes related to the [fund] account.

(3) The Oregon Military Department shall adopt rules for the disbursement of moneys from the
[Oregon Pre-Disaster Mitigation Fund] Oregon Emergency Preparedness Account.

21 SECTION 2. ORS 401.534 is amended to read:

401.534. (1) The Oregon Disaster Response [Fund] Account is established [in the State Treasury, separate and distinct from] within the General Fund. Moneys received from federal grants for disaster response efforts shall be deposited into the Oregon Disaster Response [Fund] Account. Moneys in the [fund] account are continuously appropriated to the Oregon Military Department to be used to:

27 (a) Help state agencies and local government units with immediate disaster response and re-

covery efforts related to federally declared disasters in this state; and 1

2 (b) Implement long-term hazard mitigation measures after a federally declared disaster in this state during the period of immediate recovery from the disaster. 3

(2) The [Oregon Disaster Response Fund may receive] department may deposit in the account 4 gifts, grants, bequests, endowments and donations from public and private sources for purposes re-5

lated to the [fund] account. 6

(3) The Office of Emergency Management [of the Oregon Military Department] shall adopt rules 7 for the disbursement of moneys from the [Oregon Disaster Response Fund] account. 8

9 (4) If there are expenditures from the [Oregon Disaster Response Fund] account, the Adjutant General [of the Oregon Military Department] shall report to the Emergency Board, or to the Legis-10 lative Assembly if it is in session, on: 11

12 (a) The nature and severity of the disaster;

13 (b) The actual and projected deposits into the [fund] **account**;

(c) The sources of actual and projected expenditures from the [fund] account; 14

15 (d) The nature of in-kind donations received; and

(e) The rationale for expenditures and allocation of payments to state agencies and local gov-16 ernment units. 17

18 (5) Following the final expenditure for a particular disaster, the Adjutant General [of the Oregon Military Department] shall issue a final report to the Emergency Board, or to the Legislative As-19 sembly if it is in session. The report must include an aggregate description of the factors described 20in subsection (4) of this section. 21

22SECTION 3. ORS 401.536 is amended to read:

23401.536. (1) The Oregon Local Disaster Assistance Loan and Grant [Account] Subaccount is established as [an account in] a subaccount within the Oregon Disaster Response [Fund] 24 Account. The [account] subaccount consists of moneys appropriated by the Legislative Assembly 25and any other moneys deposited into the [account] subaccount pursuant to law. 26

27(2) Moneys in the [account] subaccount are continuously appropriated to the Oregon Military Department for: 28

(a) Providing loans to local governments, as defined in ORS 174.116, and school districts to 2930 match, either in full or in part, moneys from federal programs for federally declared disaster relief 31 that require a match;

(b) Providing loans and grants to local governments, as defined in ORS 174.116, and school dis-32tricts, for the purpose of paying costs incurred by local governments and school districts in response 33 34 to federally declared disasters;

35(c) Providing loans and grants to local governments, as defined in ORS 174.116, and school districts for the purposes of paying costs incurred by local governments and school districts in re-36 37 sponse to disasters that are not federally declared disasters, as determined by the Legislative 38 Assembly, if all loans and grants provided under paragraphs (a) and (b) of this subsection have been repaid, fulfilled or otherwise satisfied and moneys remain in the [account] subaccount; and 39

(d) Subject to subsection (5) of this section, paying the **Oregon Military** Department's expenses 40 for administering loans made from the [account] subaccount under paragraph (a) of this subsection. 41 (3) Loans made under subsection (2)(b) or (c) of this section [shall]: 42

(a) Must be repaid pursuant to [such] the terms and conditions [as may be] established by the 43 Oregon Department of Administrative Services. [Loans made under subsection (2)(b) or (c) of this 44 section] 45

1	(b) May be interest free[,] or bear interest at a rate established by the Oregon Department of
<b>2</b>	Administrative Services. [Amounts repaid on loans made under subsection (2)(b) or (c) of this section
3	shall be deposited in the General Fund.]
4	(4) The Oregon Military Department shall deposit into the [account] subaccount any amounts
5	repaid on loans made under subsection (2)(a) of this section.
6	(5) The Oregon Military Department may not charge the [account] subaccount more than five
7	percent of the maximum amount in the [account] subaccount during a biennium for administrative
8	expenses attributable to a loan made under subsection (2)(a) of this section.
9	(6) An applicant may apply to the Oregon Military Department for a loan under subsection (2)(a)
10	of this section. The Oregon Military Department shall consider the application, make a recom-
11	mendation and submit the application and recommendation to the Local Disaster Assistance Review
12	Board established under subsection (7) of this section.
13	(7) The Oregon Military Department shall establish a Local Disaster Assistance Review Board
14	to:
15	(a) Review the recommendations of the department regarding loans under subsection (2)(a) of
16	this section;
17	(b) Approve, by a majority vote of members, the amount of any loan under subsection (2)(a) of
18	this section; and
19	(c) Approve, by a majority vote of members, the terms and conditions of any loan under sub-
20	section (2)(a) of this section.
21	(8) The review board shall include:
22	(a) Three members of county governing bodies, with at least one member representing a county
23	from east of the crest of the Cascade Mountains, with membership determined by the Association
24	of Oregon Counties;
25	(b) Three members of city governing bodies, with at least one member representing a city from
26	east of the crest of the Cascade Mountains, with membership determined by the League of Oregon
27	Cities;
28	(c) A representative of the office of the State Treasurer;
29	(d) A representative of the Oregon Military Department;
30	(e) A representative of school districts, with membership determined by the Oregon School
31	Boards Association;
32	(f) A representative of special districts, with membership determined by the Special Districts
33	Association of Oregon;
34	(g) A representative of the Oregon Department of Administrative Services; and
35	(h) Two additional members determined jointly by the department, the Association of Oregon
36	Counties and the League of Oregon Cities.
37	(9) The Office of Emergency Management [of the Oregon Military Department] shall adopt rules
38	establishing:
39	(a) A loan application process and application forms for loans under subsection (2)(a) of this
40	section;
41	(b) Reasonable financial terms and conditions for loans under subsection (2)(a) of this section,
42	including interest and the repayment of the loans;
43	(c) Eligibility requirements for applicants for loans under subsection (2)(a) of this section;
44	(d) The maximum amount an applicant for a loan under subsection (2)(a) of this section may

1	(e) The methodology the <b>Oregon Military</b> Department will use for charging the [account] sub-
2	account for administrative expenses; and
3	(f) Procedures for submission of recommendations to the review board for loans under subsection
4	(2)(a) of this section.
5	(10) The Oregon Military Department shall provide staff support for the review board.
6	SECTION 4. The amendments to ORS 401.532, 401.534 and 401.536 by sections 1 to 3 of this
7	2015 Act are intended to:
8	(1) Change the name of the Oregon Pre-Disaster Mitigation Fund to the Oregon Emer-
9	gency Preparedness Account;
10	(2) Change the name of the Oregon Disaster Response Fund to the Oregon Disaster Re-
11	sponse Account;
12	(3) Change the name of the Oregon Local Disaster Assistance Loan and Grant Account
13	to the Oregon Local Disaster Assistance Loan and Grant Subaccount;
14	(4) Change each fund described in subsections (1) and (2) of this section from a fund es-
15	tablished separate and distinct from the General Fund to an account established within the
16	General Fund; and
17	(5) Change the account described in subsection (3) of this section from an account within
18	the Oregon Disaster Response Fund to a subaccount within the Oregon Disaster Response
19	Account.
20	SECTION 5. This 2015 Act being necessary for the immediate preservation of the public
21	peace, health and safety, an emergency is declared to exist, and this 2015 Act takes effect
22	on its passage.
