SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Provides that agri-tourism [provider] **professional** is not liable for injury to or death of participant arising out of inherent risks of agri-tourism if agri-tourism [provider] **professional** posts certain notices. Provides exceptions.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to agri-tourism; and declaring an emergency.

3 Be It Enacted by the People of the State of Oregon:

SECTION 1. As used in sections 1 to 3 of this 2015 Act:

5 (1) "Agri-tourism activity" means an activity carried out on a farm or ranch that allows

6 members of the general public, for recreational, entertainment or educational purposes, to

7 view or enjoy rural activities, including farming, wineries, ranching and historical, cultural

8 or harvest-your-own activities or natural activities and attractions. An activity is an agri-

9 tourism activity whether or not the participant paid to participate in the activity.

10 (2) "Agri-tourism professional" means a person who is engaged in the business of pro-11 viding one or more agri-tourism activities, whether or not for compensation.

(3) "Farm or ranch" means an area of land used for the production, cultivation, growing,
harvesting or processing of agricultural products.

(4) "Inherent risks of agri-tourism activity" means those dangers or conditions that are
an integral part of an agri-tourism activity, including:

16 (a) Surface and subsurface conditions:

17 (b) Natural conditions of land, vegetation and waters;

18 (c) The behavior of wild or domestic animals;

(d) Ordinary dangers of structures or equipment ordinarily used in farming and ranching
operations; and

(e) The potential of a participant to act in a negligent manner that may contribute to
injury to the participant or others, including failing to follow instructions given by the agri tourism professional or failing to exercise reasonable caution while engaging in the agri tourism activity.

(5) "Participant" means an individual other than an agri-tourism professional who en gages in an agri-tourism activity.

(2) Subsection (1) of this section does not limit the liability of an agri-tourism profes-5 sional if the agri-tourism professional: 6

SECTION 2. (1) Except as provided in subsections (2) and (3) of this section, an agri-

tourism professional that posts the notices required under section 3 of this 2015 Act is not

liable for an injury to or the death of a participant arising from the inherent risks of an

(a) Commits an act or omission that constitutes negligence or willful or wanton disregard 7 for the safety of the participant, and that act or omission is a cause of injury to the partic-8 9 ipant;

(b) Intentionally injures the participant;

(c) Provides equipment to the participant and fails to make reasonable inspection of the 11 12equipment, and that failure is a cause of the injury to the participant;

(d) Fails to make reasonable inspection of the property on which the agri-tourism activity 13 occurs, and that failure is a cause of the injury to the participant; 14

15 (e) Has actual knowledge or reasonably should have known of a dangerous condition on the land or in the facilities or equipment used in the activity, or of the dangerous propensity 16 of a particular animal used in the activity, and does not make the danger known to the 17 participant, and the danger causes injury, damage or death to the participant; or 18

(f) Fails to obtain necessary authorization for the agri-tourism activity under ORS 19 215.213 or 215.283. 20

(3) Subsection (1) of this section does not limit the liability of an agri-tourism profes-2122sional under the product liability provisions of ORS 30.900 to 30.920.

23SECTION 3. (1) An agri-tourism professional shall conspicuously post the notice specified in subsection (2) of this section: 24

(a) At the entrance to the agri-tourism site, in black letters at least one inch in height; 25

(b) At any location where an agri-tourism activity takes place, in black letters at least 2627one inch in height; and

(c) In every written contract entered into between the agri-tourism professional and a 2829participant.

(2) The notice required by subsection (1) of this section must read as follows:

WARNING

Under Oregon law, there is no liability for an injury to or the death of a participant in 3536 an agri-tourism activity conducted at this agri-tourism location if the injury or death results 37 from the inherent risks of the agri-tourism activity. Inherent risks of agri-tourism activities are risks of injury inherent to land, equipment and animals, as well as the potential for you 38 to act in a negligent manner that may contribute to your injury or death. You are assuming 39 the risk of participating in this agri-tourism activity. 40
