SUMMARY

Appropriates moneys from General Fund to Oregon Health Authority for certain biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, tobacco tax receipts and certain federal funds, but excluding lottery funds and other federal funds, collected or received by authority for certain purposes.

Limits biennial expenditures by authority from certain lottery moneys for gambling addiction treatment and prevention.

Limits biennial expenditures by authority from certain federal funds for certain purposes.

Authorizes specified nonlimited expenditures.

Limits biennial expenditures from Public Employees' Revolving Fund and Oregon Educators Revolving Fund for benefit plan premiums and self-insurance.

Declares emergency, effective July 1, 2015.

- SECTION 1. There are appropriated to the Oregon Health Authority, for the biennium 5 beginning July 1, 2015, out of the General Fund, the following amounts, for the following 6 purposes: 7
 - **(1)** Programs \$ 1,943,158,786
 - Central services, statewide
- assessments and enterprise-10
- wide costs \$ 99,216,002 11
- **(3)** Capital improvement......\$ 699,615 12
- Debt service..... \$ 69,678,258 13
 - SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2015, as the maximum limits for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, tobacco tax receipts, provider taxes, Medicare receipts and federal funds for indirect cost recovery, Supplemental Security Income recoveries, Women, Infants and Children Program food rebates, the Coordinated School Health Program, the Edward Byrne Memorial State and Local

<u>SECTION 3.</u> Notwithstanding any other law limiting expenditures, the amount of \$11,292,564 is established for the biennium beginning July 1, 2015, as the maximum limit for payment of expenses from lottery moneys allocated from the Administrative Services Economic Development Fund to the Oregon Health Authority for gambling addiction treatment and prevention.

SECTION 4. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2015, as the maximum limits for payment of expenses from federal funds, excluding federal funds described in section 2 of this 2015 Act, collected or received by the Oregon Health Authority, for the following purposes:

- (1) Programs \$11,332,404,020
- (2) Central services, statewide
 - assessments and enterprise-
- 23 wide costs \$ 71,549,093

<u>SECTION 5.</u> For the biennium beginning July 1, 2015, the following expenditures by the Oregon Health Authority are not limited:

- (1) Expenditures from the Women, Infants and Children Program food vouchers.
- (2) Expenditures for the federal funds debt service on Build America Bonds.
- (3) Expenditures from the Oregon Medical Insurance Pool Account for payment of claims and third party administration contracts in the Oregon Medical Insurance Pool program, and for payment of claims and other costs associated with administration and support in the Oregon Reinsurance Program.
- <u>SECTION 6.</u> Notwithstanding any other law limiting expenditures, the amount of \$1,773,076,903 is established for the biennium beginning July 1, 2015, as the maximum limit for payment of expenses by the Public Employees' Benefit Board from the Public Employees' Revolving Fund for benefit plan premiums and self-insurance.
- <u>SECTION 7.</u> Notwithstanding any other law limiting expenditures, the amount of \$1,544,625,177 is established for the biennium beginning July 1, 2015, as the maximum limit for payment of expenses by the Oregon Educators Benefit Board from the Oregon Educators Revolving Fund for benefit plan premiums and self-insurance.
- <u>SECTION 8.</u> This 2015 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2015 Act takes effect July 1, 2015.
