# A-Engrossed Senate Bill 622

Ordered by the Senate April 9 Including Senate Amendments dated April 9

Sponsored by Senator GELSER, Representative BARTON; Representative KENY-GUYER

#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Adds [*legislative staff and*] personal support workers and home care workers to list of mandatory reporters of abuse of children, elderly persons and other vulnerable persons. Adds members of Legislative Assembly to list of mandatory reporters of abuse of adults with mental illness or developmental disabilities and of residents in long term care facilities.

# 4 Be It Enacted by the People of the State of Oregon:

5 **SECTION 1.** ORS 419B.005 is amended to read:

6 419B.005. As used in ORS 419B.005 to 419B.050, unless the context requires otherwise:

7 (1)(a) "Abuse" means:

8 (A) Any assault, as defined in ORS chapter 163, of a child and any physical injury to a child 9 which has been caused by other than accidental means, including any injury which appears to be 10 at variance with the explanation given of the injury.

(B) Any mental injury to a child, which shall include only observable and substantial impairment of the child's mental or psychological ability to function caused by cruelty to the child, with due regard to the culture of the child.

14 (C) Rape of a child, which includes but is not limited to rape, sodomy, unlawful sexual pene-15 tration and incest, as those acts are described in ORS chapter 163.

16 (D) Sexual abuse, as described in ORS chapter 163.

17 (E) Sexual exploitation, including but not limited to:

(i) Contributing to the sexual delinquency of a minor, as defined in ORS chapter 163, and any
other conduct which allows, employs, authorizes, permits, induces or encourages a child to engage
in the performing for people to observe or the photographing, filming, tape recording or other exhibition which, in whole or in part, depicts sexual conduct or contact, as defined in ORS 167.002 or
described in ORS 163.665 and 163.670, sexual abuse involving a child or rape of a child, but not including any conduct which is part of any investigation conducted pursuant to ORS 419B.020 or
which is designed to serve educational or other legitimate purposes; and

(ii) Allowing, permitting, encouraging or hiring a child to engage in prostitution as described in
ORS 167.007 or a commercial sex act as defined in ORS 163.266, to purchase sex with a minor as
described in ORS 163.413 or to patronize a prostitute as described in ORS 167.008.

1	(F) Negligent treatment or maltreatment of a child, including but not limited to the failure to
<b>2</b>	provide adequate food, clothing, shelter or medical care that is likely to endanger the health or
3	welfare of the child.
4	(G) Threatened harm to a child, which means subjecting a child to a substantial risk of harm
5	to the child's health or welfare.
6	(H) Buying or selling a person under 18 years of age as described in ORS 163.537.
7	(I) Permitting a person under 18 years of age to enter or remain in or upon premises where
8	methamphetamines are being manufactured.
9	(J) Unlawful exposure to a controlled substance, as defined in ORS 475.005, that subjects a child
10	to a substantial risk of harm to the child's health or safety.
11	(b) "Abuse" does not include reasonable discipline unless the discipline results in one of the
12	conditions described in paragraph (a) of this subsection.

(1) Anyone participating in good faith in the making of a report of elder abuse and who 8 has reasonable grounds for making the report shall have immunity from any **criminal or** civil li-9 ability that might otherwise be incurred or imposed with respect to the making or content of such 10 report. Any such participant shall have the same immunity with respect to participating in any ju-11 dicial proceeding resulting from such report.

(2) The identity of the person making the report shall be treated as confidential information and
shall be disclosed only with the consent of that person or by judicial process, or as required to
perform the functions under ORS 124.070.

15 **SECTION 6.** ORS 430.753 is amended to read:

(1) Anyone participating in good faith in making a report of abuse pursuant to ORS 17 430.743 and 430.765 (1) and (2) and who has reasonable grounds for making the report, shall have 18 immunity from any **criminal or** civil liability that might otherwise be incurred or imposed with re-19 spect to the making or content of the report. The participant shall have the same immunity with 20 respect to participating in any judicial proceeding resulting from the report.

(2) The identity of the person making the report shall be treated as confidential information and
shall be disclosed only with the consent of that person, by judicial order or as otherwise permitted
by ORS 430.763.
