# C-Engrossed Senate Bill 777

Ordered by the Senate June 18 Including Senate Amendments dated April 7 and April 27 and June 18

Sponsored by Senator GELSER

#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Directs Oregon 529 Savings Board to establish by rule qualified state ABLE Act program as described in federal Stephen Beck, Jr., Achieving a Better Life Experience Act of 2014. Allows persons with disabilities to establish savings accounts for disability-related expenses. Excludes distributions from account for qualified disability expenses from federal taxable income. Subtracts contributions made to account from federal taxable income when contribution is made before designated beneficiary of account attains 21 years of age.

Allows state without qualified ABLE program to contract with this state to provide residents of contracting state access to Oregon ABLE program. Specifies that amount in ABLE account is disregarded for purposes of determining

Specifies that amount in ABLE account is disregarded for purposes of determining person's financial eligibility to receive assistance or benefit authorized by law. Establishes Oregon 529 College Savings Plan Subaccount and Oregon 529 ABLE Subac-

Establishes Oregon 529 College Savings Plan Subaccount and Oregon 529 ABLE Subaccount in Oregon 529 Savings Network Fund.

[Increases, for biennium beginning July 1, 2015, limitation on expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by State Treasurer, for purposes of establishing ABLE program.] Appropriates moneys from General Fund to State Treasurer for establishment of ABLE program. Directs State Treasurer to transfer amount of appropriation from Oregon 529 ABLE Subaccount to General Fund as soon as practicable.

Directs State Treasurer and Oregon 529 Savings Board to establish qualified ABLE program not later than January 1, 2017.

Takes effect on 91st day following adjournment sine die.

The fiduciary organization may establish program provisions as the organization believes necessary to ensure account holder compliance with the provisions of ORS 458.680 and 458.685. 43 Notwithstanding ORS 458.670 (5) and 458.680 (2), a fiduciary organization may establish income and 44 net worth limitations for account holders that are lower than the income and net worth limitations 45

1 established by ORS 458.670 (5) and 458.680 (2).

2 (2) A fiduciary organization may act in partnership with other entities, including businesses, 3 government agencies, nonprofit organizations, community development corporations, community 4 action programs, housing authorities and congregations to assist in the fulfillment of fiduciary or-5 ganization responsibilities under this section and ORS 458.685 and 458.695.

6 (3) A fiduciary organization may use a reasonable portion of moneys allocated to the individual 7 development account program for administration, operation and evaluation purposes.

8 (4) A fiduciary organization selected to administer moneys directed by the state to individual 9 development account purposes or receiving tax deductible contributions shall provide the Housing 10 and Community Services Department with an annual report of the fiduciary organization's individual 11 development account program activity. The report shall be filed no later than 90 days after the end 12 of the fiscal year of the fiduciary organization. The report shall include, but is not limited to:

13 (a) The number of individual development accounts administered by the fiduciary organization;

14 (b) The amount of deposits and matching deposits for each account;

15 (c) The purpose of each account;

16 (d) The number of withdrawals made; and

(e) Any other information the department may require for the purpose of making a return oninvestment analysis.

(5) A fiduciary organization that is the account owner of a [college] savings network account for
 higher education under ORS 348.841 to 348.873:

(a) May make a qualified withdrawal only at the direction of the designated beneficiary and only
after the [college] savings network account of the account holder that was established for the designated beneficiary has been reduced to a balance of zero exclusively through qualified withdrawals
by the designated beneficiary; and

(b) May make nonqualified withdrawals only if the [college] savings network account of the account holder that was established for the designated beneficiary has a balance of less than \$100 or if the account holder or designated beneficiary has granted permission to make the withdrawal. Moneys received by a fiduciary organization from a nonqualified withdrawal made under this paragraph must be used for individual development account purposes.

(6) The department may make all reasonable and necessary rules to ensure fiduciary organiza tion compliance with this section and ORS 458.685 and 458.695.

<u>SECTION 24.</u> In addition to and not in lieu of any other appropriation, there is appropriated to the State Treasurer, for the biennium beginning July 1, 2015, out of the General Fund, the amount of \$664,743, which may be expended for the establishment of an Oregon 529 ABLE program under the Stephen Beck, Jr., Achieving a Better Life Experience Act of 2014 (Division B of P.L. 113-295) and this 2015 Act.

37 <u>SECTION 24a.</u> Notwithstanding ORS 348.856, as soon as is practicable, the State Treas 38 urer shall transfer an amount equal to the total amount of the appropriation made under
 39 section 24 of this 2015 Act from the Oregon 529 ABLE Subaccount of the Oregon 529 Savings
 40 Network Fund to the General Fund.

5 (2) For the purpose of harmonizing and clarifying statutory law, the Legislative Counsel 6 may substitute for words designating the Oregon 529 College Savings Network, wherever they 7 occur in statutory law, other words designating the Oregon 529 Savings Network.

8 <u>SECTION 27.</u> (1) The amendments to ORS 348.856 by section 11 of this 2015 Act are in-9 tended to change the name of the Oregon 529 College Savings Network Fund to the Oregon 10 529 Savings Network Fund.

(2) For the purpose of harmonizing and clarifying statutory law, the Legislative Counsel
 may substitute for words designating the Oregon 529 College Savings Network Fund, wher ever they occur in statutory law, other words designating the Oregon 529 Savings Network
 Fund.

15 SECTION 28. Sections 1 and 2 of this 2015 Act and the amendments to ORS 316.680 and 16 316.699 by sections 3 to 5 of this 2015 Act apply to distributions from and contributions to 17 ABLE accounts for tax years beginning on or after January 1, 2016.

18 <u>SECTION 29.</u> The State Treasurer and the Oregon 529 Savings Board shall establish and 19 maintain a qualified ABLE program in accordance with the requirements of section 2 of this 20 2015 Act and ORS 348.841 to 348.873, as amended by sections 6 to 18 of this 2015 Act, not later 21 than January 1, 2017.

22 <u>SECTION 30.</u> This 2015 Act takes effect on the 91st day after the date on which the 2015 23 regular session of the Seventy-eighth Legislative Assembly adjourns sine die.
