PROPOSED AMENDMENTS TO HOUSE BILL 2657

1 On page 1 of the printed bill, delete lines 5 through 30 and delete pages 2 2 through 5 and insert:

3 "SECTION 1. ORS 327.006 is amended to read:

4 "327.006. As used in ORS 327.006 to 327.133, 327.348 and 327.731 and 5 sections 1 to 3, chapter 735, Oregon Laws 2013:

"(1) 'Aggregate days membership' means the [sum of days present and ab-6 sent, according to the rules of the State Board of Education, of all resident 7 pupils] total number of days, as determined according to rules of the 8 State Board of Education that may prescribe a minimum number of 9 instructional hours for a half-day program or a full-day program, when 10 school is actually in session during a certain period and when all resident 11 pupils are present, have an excused absence or are absent for a reli-12gious observance or practice. The aggregate days membership of 13 kindergarten pupils shall be calculated on the basis of a half-day program. 14

15 "(2)(a) 'Approved transportation costs' means those costs as defined by 16 rule of the State Board of Education and is limited to those costs attribut-17 able to transporting or room and board provided in lieu of transporting:

18 "(A) Elementary school students who live at least one mile from school;

19 "(B) Secondary school students who live at least 1.5 miles from school;

"(C) Any student required to be transported for health or safety reasons, according to supplemental plans from districts that have been approved by the state board identifying students who are required to be transported for 1 health or safety reasons, including special education;

2 "(D) Preschool children with disabilities requiring transportation for 3 early intervention services provided pursuant to ORS 343.224 and 343.533;

4 "(E) Students who require payment of room and board in lieu of trans-5 portation;

6 "(F) A student transported from one school or facility to another school 7 or facility when the student attends both schools or facilities during the day 8 or week; and

9 "(G) Students participating in school-sponsored field trips that are exten-10 sions of classroom learning experiences.

11 "(b) 'Approved transportation costs' does not include the cost of con-12 structing boarding school facilities.

"(3) 'Average daily membership' or 'ADM' means the aggregate days 13 membership of a school during a certain period divided by the number of 14 days the school was actually in session during the same period. However, if 15a district school board adopts a class schedule that operates throughout the 16 year for all or any schools in the district, average daily membership shall 17 be computed by the Department of Education so that the resulting average 18 daily membership will not be higher or lower than if the board had not 19 adopted such schedule. 20

"(4) 'Consumer Price Index' means the Consumer Price Index for All Urban Consumers of the Portland, Oregon, Metropolitan Statistical Area, as compiled by the United States Department of Labor, Bureau of Labor Statistics.

²⁵ "(5) 'Kindergarten' means a kindergarten program that conforms to the ²⁶ standards and rules adopted by the State Board of Education.

"(6) 'Net operating expenditures' means the sum of expenditures of a school district in kindergarten through grade 12 for administration, instruction, attendance and health services, operation of plant, maintenance of plant, fixed charges and tuition for resident students attending in another district, as determined in accordance with the rules of the State Board of
Education, but net operating expenditures does not include transportation,
food service, student body activities, community services, capital outlay, debt
service or expenses incurred for nonresident students.

The pupil shall continue to be considered a resident of another school district under paragraph (a)(B) of this subsection.

"(c) A pupil is not considered to be a resident pupil under paragraph (a)(B) of this subsection if the pupil is attending school in a school district pursuant to ORS 339.133 (5) and in the prior year was considered to be a resident pupil under paragraph (a)(A) of this subsection because the pupil was attending school in another school district pursuant to a contract under ORS 339.125. "(1) For pupils in kindergarten, for State School Fund distributions
 made for the 2016-2017 school year.

"(2) For pupils in kindergarten and in grades one and two, for State
 School Fund distributions made for the 2017-2018 school year.

"(3) For pupils in kindergarten and in grades one through four, for
 State School Fund distributions made for the 2018-2019 school year.

"(4) For pupils in kindergarten and in grades one through eight, for
 State School Fund distributions made for the 2019-2020 school year.
