Sections 67c to 67e of this 2015 Act are added to and 6 made a part of ORS 475.300 to 475.346. 7 "SECTION 67c. The governing body of a city or county may adopt 8 ordinances that prohibit the establishment of medical marijuana 9 dispensaries or marijuana processing sites in the area subject to the 10 jurisdiction of the city or county. 11 "SECTION 67d. (1) Notwithstanding section 67c of this 2015 Act, a 12medical marijuana dispensary is not subject to an ordinance adopted 13 under section 67c of this 2015 Act if the medical marijuana dispensary: 14 "(a) Is registered under ORS 475.314 on or before May 1, 2015; and 15"(b) Is in compliance with or, if not making transfers as described 16 in ORS 475.314 (1) on or before May 1, 2015, will be in compliance with, 17 applicable ordinances of a city or county or is a land use applicant 18 whose land use application is deemed complete by a city or county and 19 in compliance with applicable ordinances of a city or county. 20"(2) Notwithstanding section 67c of this 2015 Act, a medical 21

marijuana dispensary is not subject to an ordinance adopted under

1 section 67c of this 2015 Act if the medical marijuana dispensary:

"(a) Applies to be registered under ORS 475.314 on or before July 1,
2015; and

"(b) Is in compliance with applicable ordinances of a city or county
or is a land use applicant whose land use application is deemed complete by a city or county and in compliance with applicable ordinances
of a city or county.

"(3) This section does not apply to a medical marijuana dispensary
 9 if the Oregon Health Authority revokes the registration of the medical
 10 marijuana dispensary.

"SECTION 67e. (1) Notwithstanding section 67c of this 2015 Act, a marijuana processing site is not subject to an ordinance adopted under section 67c of this 2015 Act if the person responsible for the marijuana processing site or applying to be the person responsible for the marijuana processing site:

"(a) Is registered under ORS 475.300 to 475.346 on or before the op erative date specified in section 70 of this 2015 Act;

"(b) Is processing usable marijuana as described in section 10 (1)
 of this 2015 Act on or before the operative date specified in section 70
 of this 2015 Act; and

"(c) Is in compliance with applicable ordinances of a city or county
or is a land use applicant whose land use application is deemed complete by a city or county and in compliance with applicable ordinances
of a city or county.

"(2) This section does not apply to a marijuana processing site if the
 Oregon Health Authority revokes the registration of the marijuana
 processing site.
