"ASSUMED INTEREST RATE

7 **"SECTION 1.** ORS 238.607 is amended to read:

"238.607. (1) As often as is necessary to maintain actuarial equiv-8 alence, and no less than once every two calendar years, the Public Em-9 ployees Retirement Board shall adopt actuarial equivalency factor tables for 10 the purpose of computing the payments to be made to members and their 11 beneficiaries, alternate payees and judge members and their spouses and 12beneficiaries. The tables may be adopted in conjunction with the system 13 evaluation required by ORS 238.605. Tables adopted under this section must 14 use the best actuarial information on mortality available at the time the 15board adopts the tables, as provided by the actuary engaged by the board. 16 The assumed interest rate used for tables adopted under this section 17 must be equal to the current rate, at the time of adoption, for valuing 18 annuity benefits as published from time to time by the federal Pension 19 Benefit Guaranty Corporation. Actuarial equivalency factor tables 20adopted under this section become effective [on January 1 of the calendar 21year following] upon adoption of the tables by the board or on another date 22

specified by the board. All computations of payments must use the actuarial equivalency factor tables that are in effect on:

"(a) The effective date of retirement for any member, judge member or
alternate payee;

5 "(b) The date that the first payment is due for any death beneficiary; or 6 "(c) The date that the first payment is due for any recalculation of pay-7 ments that is not attributable to error, including but not limited to recalcu-8 lations under ORS 238.465 (2).

9 "(2) The board may not defer or delay implementation of the actuarial 10 equivalency factor tables adopted under this section.

"SECTION 2. The Public Employees Retirement Board shall first 11 adopt actuarial equivalency factor tables under ORS 238.607, as 12amended by section 1 of this 2015 Act, no later than January 1, 2016. 13 The board shall use the tables first adopted under ORS 238.607, as 14 amended by section 1 of this 2015 Act, to compute the retirement al-15lowances of members, judge members and alternate payees for whom 16 the effective date of retirement is on or after the effective date of this 17 2015 Act but before January 1, 2016. 18

24 "SECTION 4. (1) A member of the system ceases to be a member 25 of the individual account program on the effective date of this 2015 26 Act. Notwithstanding ORS 238A.300, a person may not become a 27 member of the individual account program on or after the effective 28 date of this 2015 Act.

"(2) A member of the system who is a member of the individual
 account program on the effective date of this 2015 Act continues to

be a member of the individual account program for the purpose of amounts in the employee account established for the member under ORS 238A.350 (2), but no further employee contributions may be deposited in the account on or after the effective date of this 2015 Act by reason of service of the member.

6 "(3) Employee contributions under ORS 238A.330 made on or after 7 the effective date of this 2015 Act by or on behalf of a member of the 8 system may not be deposited by the Public Employees Retirement 9 Board in the employee account established for the member under ORS 10 238A.350 (2), but must instead be deposited in the account established 11 for the member under section 5 of this 2015 Act.

"SECTION 5. (1) The Public Employees Retirement Board shall es-12tablish an account for each active member of the system. Each ac-13 count shall be adjusted at least annually in accordance with rules 14 adopted by the board to reflect any net earnings or losses on contri-15 butions to the account. The adjustments described in this subsection 16 shall continue until the account is withdrawn or applied against the 17 costs of the pension and other retirement benefits payable to the 18 member. 19

"(2) Unless the amounts in an account created under this section are withdrawn under section 6 of this 2015 Act, the amounts in the account shall be applied by the board to pay the costs of the pension and other retirement benefits accrued on or after the effective date of this 2015 Act and payable to or on behalf of the member.

"(3) Any amount remaining in an account created under this section after the amounts in the account have been applied as described
in subsection (2) of this section shall be distributed to the member.

28 "<u>SECTION 6.</u> (1) An inactive member may elect to receive a dis-29 tribution of the amounts in the member's account established under 30 section 5 of this 2015 Act if the inactive member has separated from

all service with participating public employers and with employers who 1 are treated as part of a participating public employer's controlled $\mathbf{2}$ group under the federal laws and rules governing the status of the 3 Public Employees Retirement System and the Public Employees Re-4 tirement Fund as a qualified governmental retirement plan and trust. $\mathbf{5}$ "(2) A member who is vested in the pension program established 6 under this chapter and who is eligible to withdraw from the pension 7 program under ORS 238A.120 may make an election under this section 8 only if the member also withdraws from the pension program. 9

"238A.320. (1) A member of the individual account program becomes
vested in the employee account established for the member under ORS
238A.350 (2) on the date the employee account is established.

"(2) A member who makes rollover contributions becomes vested in the
rollover account established for the member under ORS 238A.350 (4) on the
date the rollover account is established.

"(3) Except as provided in subsection (4) of this section, if an employer
makes employer contributions for a member under ORS 238A.340 the member
becomes vested in the employer account established under ORS 238A.350 (3)
on the earliest of the following dates:

"(a) The date on which the member completes at least 600 hours of service
in each of five calendar years. The five calendar years need not be consecutive, but are subject to the provisions of subsection (5) of this section.

"(b) The date on which an active member reaches the normal retirementage for the member under ORS 238A.160.

"(c) If the individual account program is terminated, the date on which termination becomes effective, but only to the extent the account is then funded.

"(d) The date on which an active member becomes disabled, as described

"(4) If on the date that a person becomes an active member the person
has already reached the normal retirement age for the person under ORS
238A.160, and the employer makes employer contributions for the member
under ORS 238A.340, the person is vested in the employer account established
under ORS 238A.350 (3) on that date.

"(5) If a member of the individual account program who is not vested in the employer account performs fewer than 600 hours of service in each of five consecutive calendar years, hours of service performed before the first calendar year of the period of five consecutive calendar years shall be disregarded for purposes of determining whether the member is vested under subsection (3)(a) of this section.

"(6) Solely for purposes of determining whether a member is vested under subsection (3)(a) of this section, hours of service include creditable service, as defined in ORS 238.005, performed by the person before the person became an eligible employee, as long as the membership of the person under ORS chapter 238 has not been terminated under the provisions of ORS 238.095 on the date the person becomes an eligible employee.

"(7) A member becomes vested in the account established for the
 member under section 5 of this 2015 Act on the date the account is
 established under section 5 of this 2015 Act.

ORS 238.607 and 238A.320 by sections 1 and 7 of this 2015 Act; and
"(b) Recalculate the contribution rates of all employers, pursuant

to ORS 238.225, to reflect sections 4 to 6 of this 2015 Act and the
amendments to ORS 238.607 and 238A.320 by sections 1 and 7 of this
2015 Act.

"(2) The board shall issue corrected contribution rate orders to
employers affected by rates recalculated under this section within 90

"EXPEDITED REVIEW BY SUPREME COURT

10

"SECTION 9. (1) Jurisdiction is conferred on the Supreme Court to 11 determine in the manner provided by this section whether this 2015 12 Act breaches any contract between members of the Public Employees 13 Retirement System and their employers or violates any constitutional 14 provision, including but not limited to impairment of contract rights 15 of members of the Public Employees Retirement System under Article 16 I, section 21, of the Oregon Constitution, or Article I, section 10, 17 clause 1, of the United States Constitution. 18

"(2) A person who is adversely affected by this 2015 Act or who will be adversely affected by this 2015 Act may institute a proceeding for review by filing with the Supreme Court a petition that meets the following requirements:

23 "(a) The petition must be filed within 60 days after the effective
24 date of this 2015 Act.

25 **"(b) The petition must include the following:**

26 "(A) A statement of the basis of the challenge; and

27 "(B) A statement and supporting affidavit showing how the
28 petitioner is adversely affected.

"(3) The petitioner shall serve a copy of the petition by registered
 or certified mail upon the Public Employees Retirement Board, the

1 Attorney General and the Governor.

"(4) Proceedings for review under this section shall be given priority
 over all other matters before the Supreme Court.

"(5) The Supreme Court shall allow public employers participating
in the Public Employees Retirement System to intervene in any proceeding under this section.

"(6)(a) The Supreme Court shall allow members of the Legislative Assembly to intervene in any proceeding relating to this 2015 Act. After a member intervenes in a proceeding relating to this 2015 Act, the member has standing to participate in the proceeding even if the member ceases to be a member of the Legislative Assembly.

12 "(b) A member of the Senate or House of Representatives who in-13 tervenes in a proceeding under this subsection may not use public 14 funds to pay legal expenses incurred in intervening or participating in 15 the proceeding.

"(7) In the event the Supreme Court determines that there are
 factual issues in the petition, the Supreme Court may appoint a special
 master to hear evidence and to prepare recommended findings of fact.
 "(8) The Supreme Court may not award attorney fees to a petitioner
 in a proceeding under this section.
