"SECTION 2. Notwithstanding any other law limiting expenditures, 1 the limitation on expenditures established by section 2 (4), chapter \_\_\_\_,  $\mathbf{2}$ Oregon Laws 2015 (Enrolled House Bill 5026), for the biennium begin-3 ning July 1, 2015, as the maximum limit for payment of expenses from 4 fees, moneys or other revenues, including Miscellaneous Receipts and  $\mathbf{5}$ Medicare receipts and including federal funds for indirect cost recov-6 ery, Social Security Supplemental Security Income recoveries and the 7 Child Care and Development Fund, but excluding lottery funds and 8 federal funds not described in section 2, chapter \_\_\_\_, Oregon Laws 2015 9 (Enrolled House Bill 5026), collected or received by the Department of 10 Human Services, is increased by \$386,411. 11

"SECTION 3. Notwithstanding any other law limiting expenditures, 12 the amount of \$1,100,000 is established for the biennium beginning July 13 1, 2015, as the maximum limit for payment of expenses from fees, 14 moneys or other revenues, including Miscellaneous Receipts and re-15 imbursements from federal service agreements, but excluding lottery 16 funds and federal funds not described in this section, collected or re-17 ceived by the Department of Revenue, for the core system replacement 18 19 project.

"SECTION 4. Notwithstanding any other law limiting expenditures, 20the limitation on expenditures established by section 2 (1), chapter \_\_\_\_, 21Oregon Laws 2015 (Enrolled House Bill 5035), for the biennium begin-22ning July 1, 2015, as the maximum limit for payment of expenses from 23fees, moneys or other revenues, including Miscellaneous Receipts and 24reimbursements from federal service agreements, but excluding lottery 25funds and federal funds not described in section 2, chapter \_\_\_\_, Oregon 26Laws 2015 (Enrolled House Bill 5035), collected or received by the De-27partment of Revenue, is increased by \$145,544 for the purpose of im-28plementing chapter \_\_\_, Oregon Laws 2015 (Enrolled House Bill 2041). 29 "SECTION 5. Notwithstanding any other law limiting expenditures, 30

the limitation on expenditures established by section 2 (4), chapter \_\_\_\_, 1 Oregon Laws 2015 (Enrolled House Bill 5035), for the biennium begin- $\mathbf{2}$ ning July 1, 2015, as the maximum limit for payment of expenses from 3 fees, moneys or other revenues, including Miscellaneous Receipts and 4 reimbursements from federal service agreements, but excluding lottery  $\mathbf{5}$ funds and federal funds not described in section 2, chapter \_\_\_\_, Oregon 6 Laws 2015 (Enrolled House Bill 5035), collected or received by the De-7 partment of Revenue, is increased by \$618,909 for the purpose of im-8 plementing chapter \_\_\_\_, Oregon Laws 2015 (Enrolled House Bill 2041). 9

"SECTION 6. Notwithstanding any other law limiting expenditures, 10 the limitation on expenditures established by section 2 (1), chapter \_\_\_\_, 11 Oregon Laws 2015 (Enrolled House Bill 5002), for the biennium begin-12ning July 1, 2015, as the maximum limit for payment of expenses from 13 fees, moneys or other revenues, including Miscellaneous Receipts, and 14 including federal funds for contract services, but excluding lottery 15funds and federal funds not described in section 2, chapter \_\_\_\_, Oregon 16 Laws 2015 (Enrolled House Bill 5002), collected or received by the State 17 Department of Agriculture, is increased by \$212,641. 18

"SECTION 7. Notwithstanding any other law limiting expenditures, 19 the amount of \$8,332,933 is established for the biennium beginning July 201, 2015, as the maximum limit for payment of expenses from fees, 21moneys or other revenues, including Miscellaneous Receipts, but ex-22cluding lottery funds and federal funds, collected or received by the 23Oregon Liquor Control Commission, from the Oregon Liquor Control 24**Commission Account and the Marijuana Control and Regulation Fund** 25for expenses related to the regulation of recreational marijuana. 26

"<u>SECTION 8.</u> This 2015 Act being necessary for the immediate
preservation of the public peace, health and safety, an emergency is
declared to exist, and this 2015 Act takes effect July 1, 2015.".
