#### Oregon Rx Disposal Initiative Summary Report

The goal of this project is to reduce the number of pills available for diversion and misuse by making it easier for the public to dispose of expired, unused and unwanted prescription medications at pharmacies.

OrCRM was among the first organizations in the state to champion pharmacy based disposal and became the strategic planning body for outreach and advocacy. OrCRM's efforts began through input from pharmacists and other stakeholders attending the Eastern and Central Oregon Rx Summits in 2015. Using feedback from these summits, a subcommittee of OrCRM pharmacist leaders and pharmacy students began work on creating a pharmacist disposal toolkit to be used by pharmacies statewide to simplify the process of becoming a pharmacy disposal sites and address barriers and perceived barriers to pharmacy based disposal. The toolkit was reviewed by pharmacists, pharmacist students, and the Oregon Board of Pharmacy. The toolkit was finalized in July and distributed through the OPG website, Multnomah County website, and through various email distribution lists.

Through regional summits, outreach to regional coalitions and prevention coordinators, and direct outreach to pharmacies, pharmacy disposal has been encouraged



DOJ funds have been used to purchase disposal kiosks, pay for drug disposal, and to develop and distribute outreach materials to increase public knowledge of the importance and availability of safe medication disposal. OrCRM worked with the Tri-County **Opioid Safety Coalition's** Naloxone and Disposal

The Rx Disposal Toolkit is a step-by-step guide for pharmacies who want to provide medication disposal services to their communities. Eliminating leftover opioids and other pills from medicine cabinets can prevent misuse and abuse of medication. The guide walks pharmacists through the process of ordering and installing a DEA compliant disposal system.

### **Medication Disposal**

Customers often ask at the CMH Outpatient Pharmacy, "How do I dispose of my unwanted meds?"

We never had a great answer to this question, until now! Thanks to a rule change by the Drug Enforcement Agency, an idea by the Classop Pacific Coordinated Care Organization, and the support of our Guest Experience A-Team, our outpatient pharmacy now has a MedSafe Return Bin. This big, blue bin gives our pharmacy a secure system for disposing unwanted medications.

Each year, millions of pounds of unwanted medications are improperly disposed in the U.S. They end up in our waterways and environment. And, unwanted medications left in our homes contribute to prescription drug abuse (especially of opiates), unsafe prescription meds floating around our community, and poisonings in children.



So, drop off your unwanted medications today, and tell your friends and family. The pharmacy is open weekdays, 8AM-6PM. Simply place your bottles, vials, or tubes in the bin. There is no cost, and no questions asked. Thank you for helping our community!

### Disposal Program Highlight: Columbia Memorial Hospital Outpatient Pharmacy (CMH)

Columbia Memorial Hospital jumped at the opportunity to provide safe medication disposal to their patients. Using the kick start funding, Columbia Memorial published information in their hospital newsletter and distributed a post card to all households in Astoria about their new disposal kiosk. In one month CMH collected 38 pounds of unused medication.

Workgroup to develop a generic and customizable "bag stuffer" to help pharmacies educate the public about disposal by distributing information on safe disposal when filling opioid prescriptions.

The statewide strategic plan includes immediate impact actions such as the kick-start funding and technical assistance for pharmacies and providers, pharmacist and public education efforts through web, mailers, fliers, and coalition groups. Long term sustainability strategies include embedding disposal into pharmacist and health care provider curriculum and pursuing product stewardship legislation to require manufacturers to shoulder the cost burden of disposal.

#### **NEXT STEPS:**

- Continue outreach efforts with emphasis on pharmacy groups, pharmacy programs and CCOs
- Continue implementation and technical assistance of pharmacy disposal kiosks
- Develop and distribute public outreach materials to increase use of disposal kiosks
- Develop measurement and evaluation criteria for pharmacy based disposal
- Ensure disposal sustainability through legislative, fundraising and education efforts
