- Eleven members
  - Two legislators appointed by the President of the Senate and the Speaker of the House for two-year terms (**REP. ALONSO LEON**) – Not subject to Senate confirmation.
  - Eleven members appointed by the Governor for three-year terms (**BENDER, CASTILLO, CHAVEZ BAEZ, GALLEGOS, GOMEZ, HERNANDEZ, LOPEZ-CEVALLOS, MORENO, PARKER, SALINAS,**)
- Appointments shall be made to insure representation of Hispanics in Oregon

**DUTIES AND AUTHORITY:**                      **ORS 185.320 to ORS 185.340**

- Elect a chairperson and vice-chairperson
- Monitor existing programs and legislation designed to meet the needs of Hispanics
- Recommend actions to the Governor and Legislative Assembly following research of problem areas
- Maintain a liaison between the Hispanic community and government entities
- Encourage Hispanic representation on state boards and commissions
- Employ and executive director and other staff
- Establish special committees as necessary
