- Seven members
 - Four members who are active licensed denturists (BREMER, CHAPMAN, HVASS, MAYO)
 - One member who is a practicing Oregon licensed dentist (BINDER)
 - Two members of the public (COLLVER, CUNNINGHAM)
- Members shall serve three-year terms, may serve two consecutive terms, but a period of three years must pass before a person may be appointed again
- Members are entitled to compensation and expenses
