Testimony: Mary Middleton, Oregonians for Safe Farms and Families, Josephine County Oregon

Thank you Rep. Clem and all members of the House Committee on Agriculture and Natural Resources for holding this hearing today and for the opportunity to speak with you to request your support of HB 2469.

My name is Mary Middleton, Director of Oregonians for Safe Farms and Families. I am here today representing the 16,137 citizens who overwhelmingly voted to adopt the Josephine County Genetically Engineered Plant Ordinance in May 2014. Jackson County voters enacted a similar ordinance the same day, effectively making Southern Oregon a GMO-Free Zone.

Our citizenry as a whole has a strong belief and respect in the political process.

During the 2014 campaign, more than 50 farms, hundreds of farmers, and more than 150 local businesses signed on in support of the Ordinance to protect our farms and community.

Agriculture is a matter of local concern, because here in Oregon unlike most other State's, our State consists of many small family farms. To date, the legislature has failed to pass any comprehensive statewide regulation to address the mounting needs of small family farmers across the state. In this void, I am here today asking you to restore Oregon's home rule and democratic process that allows every day citizens and small farmers to go to the ballot to address their community's needs to regulate seeds. The Will of the People, in rejecting GE crops to protect family farms, was made very clear in southern Oregon. Voters across the state should have the opportunity to regulate seeds at a local level. Therefore, I am asking you to support HB 2469, which not only honors the will of the people of

Josephine County, but will also allow other communities throughout Oregon to put the interests of local family farms above the interests of outside chemical corporations.

I've brought with me 173 letters from Josephine County citizens in support of HB 2469. These are copies of just a portion of the letters sent to our elected officials from the region and I bring these letters to further show support of the will of the people in Josephine County.

Finally, I'd like to end with a point of discussion also presented to you by the Oregon Farm Bureau earlier this year. In Oregon, our farmers and communities need FLEXIBILITY. The Flexibility to make their own agricultural decisions. The flexibility to protect our rural communities and the flexibility to utilize the legislative process set forth by our forefathers. Siskiyou Seeds is a certified Organic Seed Company in Josephine County in SW Oregon that specializes in open-pollinated and Heirloom vegetable, flower and herb seeds. We distribute widely throughout Oregon and nationwide through on-line sales. We employ 10 people in our seed house and on our production farm. We grow much of the seeds ourselves and source the rest from other Organic growers in Oregon, many of whom are in Josephine and Jackson County.

As we a certified Organic Farm with the Oregon Department of Agriculture, our products must be produced in accordance with the USDA's National Organic Program (NOP), which prohibits contamination, by transgenic GE pollen. Contamination of a seed crop with GE pollen is distinctly possible for Beets, Chard, Corn, some Mustards and can render the crop virtually worthless for sale as Organic. Our business model is based upon our certified Organic status and our clientele looks to Siskiyou Seeds to assure them that they are purchasing and planting seed free of GE contamination. We grow over 400 varieties of crops including 35 varieties of the aforementioned species that are at risk from GE contamination from de-regulated GE crops being grown in Oregon including Roundup Ready Sugar Beets, GE Canola & GE Corn).

The cost for testing for GE contamination can range between \$300-400, plus the cost of the seed sample (5 pounds for corn) and the time expense. Testing of the 35 varieties mentioned above would cost up to \$16,000 annually. This is unacceptable. The citizens of both Josephine and Jackson County overwhelmingly voted to ban the cultivation of GE crops in May of 2014, thus putting the economic interests of local farmers like me ahead of the economic interests of large multinational biotech corporations.





However the future of sustainable profits from local agriculture is proving to be all about a commitment to organic, which means among other things, non-GMO growing methods.

As I'm sure you are aware, HB 2469 provides the legal means for JoCo to enforce the Genetically Engineered Plant Ordinance passed by the local voters. I voted for it. The freedom for local farmers to be able grow, produce, and sell truly organic, non-GMO foods is one of the most important local issues for me.

While the Grower's market still has a few booths focused on conventionally produced foods (delicious donuts, hot dogs and the like) it is absolutely abundant and bursting with locally produced organic items. Organic has basically become the reason the majority of shoppers go there. One look anytime from May Thru Oct. is all it takes to verify that point.

Another point of interest. At my business, Sunshine Natural Foods in Grants Pass, we have featured an organic salad bar for over 2 decades. Until recently it was impossible for us to place standing weekly orders with local organic farmers for 3 or 4 cases of lettuce and other vegetables even during the summer. They couldn't reliably deliver in quantity. We had to import produce from the Willamette valley.

The last 2 to 3 years local organic farmers have been able to fulfill many more of our needs with consistent weekly deliveries of hundreds of pounds of beautiful produce. Organic farming has fully arrived in JoCo.



As I'm sure you're aware, many local vegetable farmers also grow pot. Clean pure products without the chemical residues that are part and parcel to GMO growing methods (glyphosate, etc) are critical for that industry as well.

In conclusion, I would hope that you sponsor and support HB 2469. It is a long-term step you can take to help bolster and ensure that JoCo economy has an industry that continues to thrive and expand.
