Subject: Response to Committee Questions on Dam Safety

During the March 14 informational hearing, the Department was asked to provide the committee with a list of high-hazard dams and whether those dams: (1) are privately or publically owned, (2) have emergency action plans, and (3) have early warning systems. There are currently 75 high-hazard dams, with 58 of those structures having emergency action plans and 13 having early warning systems. Below is a list of the high-hazard dams with the information requested.
