HB 2556 Oppose Felony Status, Fines, Manufacturing, Distribution and Sales of Paraphernalia. Support being 21 years of age to purchase Paraphernalia.

I support that anybody purchasing paraphernalia should have to be 21 yrs old. I strongly disagree that Glassware and Pipes should be limited to only OLCC Recreational and Medical Stores. Oregon has a long standing Free Market for Glassware and Craftsman designed Pipes and Artistic glassware. The product have always been used for Tobacco, Herbs and Cannabis. The Free Market should be allow to continue to flourish as independent Artists supplying products for Legal Activities. Limiting sales to over 21 is acceptable. A Felony for manufacturing or selling glassware and pipes at a Flea Market or Private Business is Completely Unacceptable. OLCC confiscation of Artist creations of Glassware and Pipes is a Nazi policing policy maneuver. It is not against the Oregon Constitution to smoke tobacco and cannabis. It should not be illegal to possess, manufacture or sell paraphernalia to anybody over 21 years of age. This is one of the worse written bills that I have read and I have read thousands.
