## ODFW Budget Testimony 3/29/17

Co-Chair Senator Frederick and co-chair Representative Witt and Members of the Committee.

My name is Rob Bignall, a fishing guide, living in Sherwood, Oregon. I am representing the Northwest Guides and Anglers Association.

My testimony today is based on attending previous ODFW Commission meetings where the controversy of commercial fishermen's use of gillnets continues.

SB 830 was established to phase gillnets out from the mainstem of the Columbia River. With the lack of support given by Commission and their disregard of ODFW Staffs recommendation we have regressed from the proposals of SB 830.

So, in observation of the pie charts presented by ODFW staff on Monday there are 680,000 angler license holders of which 9,845 have purchased the Columbia River Endorsement.

I cannot connect the dots in thinking there is 88% credibility for ODFW and a 95% confidence level between sportsman and the Department because your stated pool is of 900 Oregonians and appears not to representative of sports community that pays the bills for ODFW. Overall this is not at all a warm and fuzzy story.

The financial status of this department is dependent on recreational sportsman where 66% are Anglers, 33% are Hunters and we really have little to show for it other than your hand is in our back pocket in sustaining this department. The recreational community contributes \$2.5 billion annually to the Oregon Economy.


The ODFW Commission has damaged the relationship between ODFW and recreational sportsman; they have created a division between Washington and Oregon that have a time honored 100 year old compact in shared management that affects hundreds of thousands of families that are dependent on the sales relating to fishing.

This is all over not following the policies ratified by our legislature under SB830.

Commercial fishing takes 2.5 times more fish as the recreational and they only contribute 4% the ODFW budget.

Under the business side of parody this would never fly, where 4% of the ODFW budget is controlled by 148 commercial permit holders that average less than \$23K per year, 70 of those make less than \$10K per year, and 50% of the ODFW budget is made up of 680,000 recreational fishermen with 2.5 times less fish taken.

Sport: \$214.78 per kept fish2

On another note I have great respect in what you do as elected or volunteer officials when you have the words Senator, Representative, Director or Commissioner attached to your names.

But, what went on during the last Commission meeting on March 17<sup>th</sup> was way out of line. I watched a Commission panel being run by two of its member's brow beating the other members into submission for a unanimous vote taking SB 830 backwards.

Then I watched commission member Holly Akenson belittle, chastise, and degrade the ODFW staff and legislature in front of the total gallery over their requested projection of financial values for reduced agency funding that was condoned by fisheries Director Ed Bowles and ODFW Director Melcher.

So in conclusion, where is all the warm and fuzzy support for ODFW because the disproportional membership of our Commission or what I call "gillnet lobbyists" goals are to support a commercial industry that takes 50 % of the salmon resource participating only in 4% of the ODFW budget. Should we continue down this path ODFW financial status will continue to be in trouble.
