DUTIES AND AUTHORITY: Oregon Constitution Article XV, Section 4, Paragraph 4a, ORS 461.100, 461.120, and 461.130

- All power necessary to effectuate Oregon Constitution Article XV, Section 4 and ORS Ch. 461 (State Lottery Law)
