I was able to double check with both our Child Protective Services Manager, Stacey Ayers, and our legal counsel at DOJ and confirm that the language in the A-Engrossed version of the bill allows us the discretion to withhold disclosure of information related to a child abuse report or assessment if doing so would be a danger to the child(ren) or an impediment to the investigation.
